 EH#18658 In Summary: This is a Gang Investigation Division arrest by Beat 6570a and assisting G.I.D. units. While on patrol, the arresting officers heard gun shots and then observed the arrestee firing a handgun into an occupied vehicle which resulted in the listed victims death. At that time, the arresting officers announced their office and gave the arrestee verbal commands to drop his weapon, to which the arrestee did not comply. In fear for their lives and that of the general public, the arresting officers then fired their duty weapons and thereafter placed the arrestee into custody. The arrestee was then transported to Stroger Hospital by CFD ambulance 44 and treated by Dr. Dennis.
