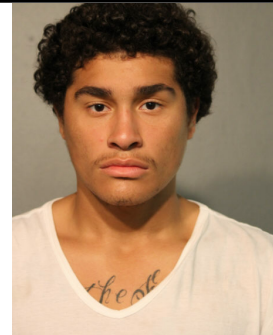

EVENT # 14873. BWC INCIDENT. VIDEO WAS VIEWED. IN SUMMARY: R/O KHAN # 4471 OBSERVED ENRIQUE CARLO(OFFENDER), A KNOWN AND DOCUMENTED 014TH DISTRICT CAR THIEF WITH MULTIPLE PRIOR ARRESTS FOR BEING IN STOLEN VEHICLES AS WELL AS A VEHICULAR HIJACKING -AGG.FIREARM DRIVING A LAND ROVER TRAVELLING WESTBOUND NORTH AVE. APPROXIMATELY 3532 W. NORTH FAILING TO WEAR A SEATBELT. R/O'S TRAVELLING EASTBOUND NORTH AVE. MADE A U-TURN ACTIVATING EMERGENCY EQUIPMENT IN AN ATTEMPT TO CURB SAID VEHICLE. LISTED VEHICLE DRIVEN BY ENRIQUE CARLO(OFFENDER) FAILED TO STOP FLEEING WESTBOUND ON NORTH AVE. R/O'S IMMEDIATELY INFORMED OEMC PROVIDING IL REGISTRATION [REDACTED] OF SAID LAND ROVER RANGE ROVER. OEMC INFORMED R/O'S LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) WAS STOLEN. LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) FAILED TO STOP AT SOLID RED SIGNALS AT HAMLIN, PULASKI, AND GRAND WEAVING IN AND OUT OF TRAFFIC DRIVING ERRATICALLY FLEEING FROM POLICE. LISTED VEHICLE CUT THROUGH A BP GAS STATION LOCATED AT THE CORNER OF GRAND AND NORTH BEFORE USING THE NORTH ALLEY OF NORTH AVE (4400 TO 4532 WEST) AS A THRU STREET MAKING A RIGHT TURN ONTO KOLMAR(NORTHBOUND). LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) PULLED INTO AN EMPTY LOT COVERED WITH GRAVEL LOCATED AT 4523 W. GRAND (GRAND AND KOLMAR) RUNNING OVER A POSTED SIGN BEFORE STRIKING A BILLBOARD DAMAGING THE FRONT END OF LISTED STOLEN VEHICLE. OFFENDER AND CO-ARRESTEES FLED WITH R/O'S GIVING CHASE. KNOWING THE DRIVER TO BE ENRIQUE CARLO(OFFENDER), RO KHAN #4471 ONCE AGAIN INFORMED RESPONDING ASSISTING OFFICERS WHO THE DRIVER OF LISTED STOLEN VEHICLE WAS PROVIDING A DESCRIPTION. BT 4561B OBSERVED ENRIQUE CARLO(OFFENDER) HIDING IN A PARKING LOT JUST EAST OF KILBOURN BETWEEN NORTH AND GRAND AVES. A FOOT CHASE ENSUED WITH BT. 1422 PLACING ENRIQUE CARLO(OFFENDER) INTO CUSTODY AT 1707 N. KOSTNER. OFFENDER TRANSPORTED TO THE 014TH DISTRICT FOR PROCESSING. A YOUNG GIRL NOW KNOWN AS [REDACTED] ( [REDACTED] WAS WITH OFFENDER DURING THIS INCIDENT. [REDACTED] WITH NO VISIBLE INJURIES WAS TRANSPORTED TO THE 014TH DISTRICT BY BT. 1461D. CFD AMBULANCE #62 WAS REQUESTED TO THE 014TH DISTRICT TO EXAMINE HER. [REDACTED] WAS TURNED OVER TO HER AUNT [REDACTED] ( [REDACTED] WHO ARRIVED AT THE 014TH DISTRICT. OFFENDER WAS MIRANDIZED BY R/O KHAN IN THE PRESENCE OF LARA AT 2118 HOURS POST MIRANDA OFFENDER INVOKED HIS RIGHT TO REMAIN SILENT. OWNER OF STOLEN VEHICLE [REDACTED] (VICTIM AND COMPLAINANT) ARRIVED AT THE 014TH DISTRICT TO SIGN COMPLAINTS. [REDACTED] (VICTIM AND COMPLAINANT) STATED HE DID NOT GIVE ANYONE PERMISSION TO ENTER, TAKE, OR REMAIN IN HIS VEHICLE. NAME CHECK REVEALED ENRIQUE CARLO(OFFENDER) TO HAVE A SUSPENDED DRIVER'S LICENSE. OFFENDER IS A SELF-ADMITTED CAMPBELL BOY.
