#05409 IN SUMMARY: THIS IS A BWC INCIDENT. WITNESSES RELATED THAT SHE OBSERVED PARTA HUFF(OFFENDER)'S VEHICLE CRASHED INTO ROOSEVELT LIQUORS. WITNESSES THEN OBSERVED PARTA HUFF(OFFENDER) EXIT THE VEHICLE AND WALK E/B ON ROOSEVELT. VERONICA MURILLO (VICTIM) AND GEORGE MOUSSA (VICTIM) ARRIVED ON THE SCENE AND ATTEMPTED TO INTERVIEW PARTA HUFF(OFFENDER) AT WHICH TIME A STRUGGLE ENSUED. PARTA HUFF(OFFENDER) STRUCK VERONICA MURILLO (VICTIM) NUMEROUS TIMES ABOUT THE FACE AND BODY THEN REPEATEDLY SMASHED HER FACE INTO THE PAVEMENT UNTIL SHE WAS RENDERED UNCONSCIOUS. GEORGE MOUSSA (VICTIM) CALLED A 10-1, TASED, AND MACED PARTA HUFF(OFFENDER) IN AN ATTEMPT TO STOP PARTA HUFF(OFFENDER) ATTACK ON VERONICA MURILLO (VICTIM). PARTA HUFF(OFFENDER) THEN STRUCK GEORGE MOUSSA (VICTIM). GEORGE MOUSSA (VICTIM) AND JEROME WARNER (VICTIM) ATTEMPTED

NARRATIVES

TO PULL PARTA HUFF(OFFENDER) OFF OF VERONICA MURILLO (VICTIM). VERONICA MURILLO (VICTIM) WAS ADMITTED FOR OBSERVATION AFTER SUSTAINING MULTIPLE LACERATIONS TO HER FACE AND A CONCUSSION. GEORGE MOUSSA (VICTIM) WAS TREATED AND RELEASED FOR AN INJURY TO HIS RIGHT HAND AND A TORN LEFT QUAD. JEROME WARNER (VICTIM) WAS TREATED AND RELEASED FOR INJURIES TO BOTH HANDS AND AN INCREASED HEART RATE THAT LEAD TO SIGNIFICANT CHEST PAIN.
