NARRATIVE

E#11267 IN SUMMARY, A/O'S RESPONDED TO A CALL AT LISTED LOCATION, WALGREENS, OF A PERSON REFUSING TO LEAVE SAID LOCATION AND OF THREATENING PEOPLE. ON SCENE, [REDACTED] (VICTIM AND COMPLAINANT) RELATED THAT AFTER LEONARD ACKERMAN(OFFENDER) WAS CAUSING A DISTURBANCE AT THE STORE, PHARMACY SECTION(HE WAS ATTEMPTING TO REFILL HIS PRESCRIPTION PREMATURELY), HE WAS REPEATEDLY ASKED TO LEAVE SAID STORE. HE REFUSED. LEONARD ACKERMAN(OFFENDER) THEN JABBED [REDACTED] (VICTIM AND COMPLAINANT) IN THE CHEST WITH HIS FINGERS, STATING THAT IF [REDACTED] (VICTIM) CALLED THE POLICE, HE WOULD RETURN TO "GET THEM" (VICTIM [REDACTED] AND LISTED WITNESSES FURTHER RELATED THEIR CONCERN THAT SUBJECT TOOK PHOTOGRAPHS OF THEM). AS OFFICERS STATED TO LEONARD ACKERMAN(OFFENDER) THAT HE WAS UNDER ARREST AND TO PLACE HIS HANDS BEHIND HIS BACK, HE RESPONDED IN THE NEGATIVE, STATED "THE FUCK YOU ARE." IN AN ATTEMPT TO PLACE LEONARD ACKERMAN(OFFENDER) INTO CUSTODY, HE RESISTED; HE PULLED AWAY FROM A/O'S, SWUNG HIS ARMS, STIFFENED HIS BODY ALL IN AN EFFORT TO DEFEAT THE LAWFUL ARREST. WHILE ATTEMPTING TO EFFECT THE ARREST USING WRIST LOCKS AND ARM BAR AND REPEATED DIRECTIONS TO STOP RESISTING, LEONARD ACKERMAN(OFFENDER) CONTINUED TO TWIST HIS BODY, RESULTING IN AN INJURY TO HIS LEFT ELBOW AREA. A/O'S IMMEDIATELY REQUESTED AN AMBULANCE FOR LEONARD ACKERMAN(OFFENDER). HE WAS ESCORTED BY BT 2005 TO SWEDISH COVENANT HOSPITAL; SEEN BY DR. NORMAN. DURING THE STRUGGLE OF LEONARD ACKERMAN(OFFENDER) IN THE RESISTING OF THE ARREST, P.O. MARK CZAPLA (VICTIM AND COMPLAINANT)SUFFERED LACERATIONS TO HIS RIGHT HAND. LEONARD ACKERMAN(OFFENDER) CHARGED: 720 ILCS 5/12-3-A-2, BATTERY-MAKE PHYSICAL CONTACT; 720 ILCS 5/21-3-A-3, CRIMINAL TRESPASS-REMAIN ON LAND; AND 520 ILCS 5/1.22, RESISTING OFFICER (BOTH OFFICERS, TWO CHARGES). [REDACTED] (VICTIM) WAS GIVEN COURT DATE OF 28 JUL 2014 AT 29-4, 1300 HOURS, AND ADVISED TO APPEAR. TACTICAL RESPONSE REPORTS WERE COMPLETED. THIS IS A VIDEO RECORDED INCIDENT, UNDER INVENTORY NUMBER OF 13204010.
