EVENT #16771 IN SUMMARY A/O RESPONDED TO A CALL RE: SUSPICIOUS PERSON. A/O ARMED WITH DESCRIPTION GIVEN BY IN-CAR PDT (M/H PUERTO RICAN DARK CAP, WHITE T-SHIRT, JEANS, BACK PACK) TOURED THE AREA. A/O OBSERVED ABOVE (MATCHING DESCRIPTION GIVEN) DUCKING AND HIDING IN THE SHADOWS, AND IN BETWEEN PARKED VEHICLES AT APPROXIMATELY 4323 W. 30TH ST. A/O ATTEMPTED TO DETAIN ABOVE, BUT ABOVE BEGAN TO FLEE AND BEGAN TO STRUGGLE WITH A/O AT APPROXIMATELY 4320 W. 30TH ST. ABOVE REFUSED VERBAL DIRECTION, PULLED AWAY FROM A/O, AND ATTEMPTED TO CONTINUE FLEEING ON FOOT. A/O WAS FORCED TO USE AN EMERGENCY TAKEDOWN AND OPEN HAND STRIKES. DURING THE TAKEDOWN ABOVE STRUCK THE BACK OF HIS HEAD ON THE CURB AT APPROXIMATELY 4320 W. 30TH STREET CAUSING A LACERATION TO THE REAR OF HIS HEAD AND OTHER LACERATIONS ABOUT HIS HANDS. ABOVE WAS STILL STRUGGLING AND A/O WERE FORCED TO PLACE HANDCUFFS ON ABOVE. A/O THEN RELOCATED TO [REDACTED]

WITNESS 1 RELATED THAT SHE [REDACTED] HEARD A CONSTANT BANGING ON THE REAR YARD COMMON DOOR. WITNESS 1 OPENED THE STATED DOOR AND SAW ABOVE. ABOVE RELATED THAT HE WAS THERE TO SEE THE MAN WHO LIVED IN THE ATTIC APARTMENT. ABOVE PROCEEDED UP STAIRS AND WITNESS 1 WENT BACK INTO HER APARTMENT. WITNESS 1 LATER SAW ABOVE COMING DOWN THE STAIRS HOLDING A LARGE BLACK FLAT SCREEN TELEVISION. WITNESS 1 REMEMBERED THAT THE ATTIC RESIDENT WAS OUT OF TOWN AND WAS NOT SUPPOSED TO RETURN UNTIL MONDAY. WITNESS 1 HAD WITNESS 2 ([REDACTED]) CHECK THE ATTIC APARTMENT. WITNESS 2 RELATED THAT HE OBSERVED THE ATTIC APARTMENT DOOR WAS PRIED OPEN AND THAT THE ENTERTAINMENT CENTER WAS MISSING ITS TELEVISION. WITNESS 2 (ALONG WITH WITNESS 1) RAN DOWN THE STAIRS AND OUTSIDE TO THE BACKYARD WHERE THEY BOTH OBSERVED ABOVE STRUGGLING TO GET OUT OF THE LOCKED REAR GATE (BY ALLEY) ABOVE WAS NOW ALSO IN POSSESSION OF A GREEN BICYCLE BELONGING TO WITNESS 1/VICTIM 2. ABOVE RELATED TO WITNESS 1 AND 2 NOT VERBATIM AND IN SPANISH THAT YOU BETTER NOT SAY ANYTHING OR YOU BETTER WATCH YOURSELF (PLACING BOTH WITNESS 1 AND 2 IN FEAR OF RECEIVING A BATTERY). ABOVE THEN PROCEEDED TO RUN PAST (STILL HOLDING THE STATED TELEVISION AND GREEN BICYCLE) WITNESS 1 AND 2 AND FLED OUT OF THE BACKYARD THROUGH THE GANGWAY AND THEN S/B ON KILDARE. WITNESS 3 [REDACTED] WITNESSED THE ENTIRE BACKYARD INCIDENT [REDACTED]

WITNESS 2 FOLLOWED ABOVE ON FOOT AND WITNESSED ABOVE RUN TO AN AWAITING BLACK MERCEDES BENZ AT APPROXIMATELY 2852 S. KOLIN. ABOVE PLACED THE STATED TELEVISION AND BICYCLE INTO THE STATED VEHICLE AND THEN THE STATED VEHICLE FLED N/B ON KOLIN AND W/B ON 28 ST MAKING GOOD ITS ESCAPE. A/O RELOCATED WITNESS 1, 2, AND 3 TO 4320 W. 30TH ST WHERE THEY POSITIVELY IDENTIFIED BY ABOVE AS THE PERSON THEY SAW CARRYING THE STATED TELEVISION AND BICYCLE SEPARATELY. WITNESS 1 PLACED A/O IN TOUCH WITH VICTIM. VICTIM RELATED THAT HE HAD NOT GIVEN ANYONE PERMISSION TO ENTER HIS APARTMENT AND/OR TAKE HIS NEW 55INCH SONY FLAT SCREEN TELEVISION. WITNESS 1/VICTIM 2 RELATED THAT SHE DID NOT GIVE ANYONE PERMISSION TO TAKE HER GREEN BICYCLE THAT WAS SECURED WITHIN THE BACK STAIRWELL INSIDE THE LOCKED COMMON STAIRWELL. FOLLOWING POSITIVE IDENTIFICATION ABOVE STARTED UTTERING, "I WAS HELPING "PEEL"? I CAN GET THE TV AND BICYCLE BACK-ONLY IF THEY PROMISE NOT TO CHARGE ME I CAN GET THEIR SHIT BACK. PEEL TOOK THE TV IN A BLACK MERCEDES. PEEL LIVES ALONG CERMAK/KOSTNER. PEEL IS MEXICAN". ABOVE ALSO DESCRIBED TO A/O WHERE DROPPED THE STATED TELEVISION REMOTE CONTROL. A/O RELOCATED TO THE DESCRIBED LOCATION AND RECOVERED 1 BLACK SONY TV REMOTE CONTROL FROM THE GRASS (APPROXIMATELY 2852 S. KOLIN). ALL VICTIMS SIGNED COMPLAINTS (VICTIM AUTHORIZED A/O TO SIGN COMPLAINTS ON HIS BEHALF). AS A/O WAS HELPING ABOVE UP TO HIS FEET, ABOVE LUNGED AT A/O HONDA #3478 STICKING A/O ON HIS LEFT THIGH WITH ABOVES HEAD. ABOVE THEN PROCEEDED TO WIPE THE REAR OF HIS HEAD (BLOOD) ON A/O'S LEFT THIGH PANT LEG. ABOVE WAS READ RIGHTS (PER PRE-PRINTED CARD) AND THEN TRANSPORTED TO 010 FOR FURTHER PROCESSING. ABOVE TREATED AND RELEASED AT MT SINAI HOSPITAL BY DR WIDELL FOR A LACERATION TO THE REAR OF HIS HEAD. -NOTIFIED:-A/O'S CW2 TO ORDER AN E.T..
