EVENT # 14873. BWC INCIDENT. VIDEO WAS VIEWED. IN SUMMARY: R/O'S OBSERVED ENRIQUE CARLO(OFFENDER), A KNOWN AND DOCUMENTED 014TH DISTRICT CAR THIEF WITH MULTIPLE PRIOR ARRESTS FOR BEING IN STOLEN VEHICLES AS WELL AS A VEHICULAR HIJACKING -AGG.FIREARM DRIVING A LAND ROVER TRAVELLING WESTBOUND NORTH AVE. APPROXIMATELY 3532 W. NORTH FAILING TO WEAR A SEATBELT. R/O'S TRAVELLING EASTBOUND NORTH AVE. MADE A U-TURN ACTIVATING EMERGENCY EQUIPMENT IN AN ATTEMPT TO CURB SAID VEHICLE. LISTED VEHICLE DRIVEN BY ENRIQUE CARLO(OFFENDER) FAILED TO STOP FLEEING WESTBOUND ON NORTH AVE. R/O'S IMMEDIATELY INFORMED OEMC PROVIDING IL REGISTRATION [REDACTED] OF SAID LAND ROVER RANGE ROVER. OEMC INFORMED R/O'S LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) WAS STOLEN. LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) FAILED TO STOP AT SOLID RED SIGNALS AT HAMLIN, PULASKI, AND GRAND WEAVING IN AND OUT OF TRAFFIC DRIVING ERRATICALLY FLEEING FROM POLICE. LISTED VEHICLE CUT THROUGH A BP GAS STATION LOCATED AT THE CORNER OF GRAND AND NORTH BEFORE USING THE NORTH ALLEY OF NORTH AVE (4400 TO 4532 WEST) AS A THRU STREET MAKING A RIGHT TURN ONTO KOLMAR(NORTHBOUND). LISTED VEHICLE OPERATED BY ENRIQUE CARLO(OFFENDER) PULLED INTO AN EMPTY LOT COVERED WITH GRAVEL LOCATED AT 4523 W. GRAND (GRAND AND KOLMAR) RUNNING OVER A POSTED SIGN BEFORE STRIKING A BILLBOARD SIGN POST DAMAGING THE FRONT END OF LISTED STOLEN VEHICLE. JUSTIN TAYLOR(OFFENDER) JUMPED OUT OF THE FRONT PASSENGER SEAT WITH R/O LARA #13954 PERFORMING AN EMERGENCY TAKEDOWN. JUSTIN TAYLOR(OFFENDER) BEGAN FLAILING HIS ARMS PULLING AWAY IN AN ATTEMPT TO DEFEAT A LAWFUL ARREST. R/O LARA #13954 WAS ON TOP OF JUSTIN TAYLOR(OFFENDER) HOWEVER UNABLE TO PLACE HIM IN HANDCUFFS DUE TO RESISTANCE. SGT. VALE # 1087 STUNNED JUSTIN TAYLOR(OFFENDER) WITH THE BOTTOM OF HIS FOOT TEMPORALLY CAUSING JUSTIN TAYLOR(OFFENDER) TO STOP RESISTING ALLOWING R/O LARA #13954 TO PLACE HANDCUFFS ON HIM. EMERGENCY TAKE DOWN AND HANDCUFFING ON A GRAVEL GROUND LEFT JUSTIN TAYLOR(OFFENDER) WITH A BRUISED CHEEK, SCRATCHES ON HIS CHIN, AND AN ABRASION TO HIS LEG. IGNACIO MUNGUIA(OFFENDER) FLED FROM THE REAR OF LISTED VEHICLE CARRYING A YOUNG GIRL NOW KNOWN AS DESTINEY STEWART (DOB:04 SEP. 2012) WITH R/O KHAN #4471 GIVING CHASE. IGNACIO MUNGUIA(OFFENDER) WAS PLACED INTO CUSTODY AT 1626 N. KOLMAR. SGT. VALE CAME TO ASSIST R/O KHAN TAKING CUSTODY OF IGNACIO MUNGUIA(OFFENDER). R/O KHAN RAN IN THE DIRECTION TOWARD WHICH THE DRIVER ENRIQUE CARLO(OFFENDER) FLED. KNOWING THE DRIVER TO BE ENRIQUE CARLO(OFFENDER), RO KHAN #4471 ONCE AGAIN INFORMED RESPONDING ASSISTING OFFICERS WHO THE DRIVER OF LISTED STOLEN VEHICLE WAS PROVIDING A DESCRIPTION. BT 4561B OBSERVED ENRIQUE CARLO(OFFENDER) HIDING IN A PARKING LOT JUST EAST OF KILBOURN BETWEEN NORTH AND GRAND AVES. A FOOT CHASE ENSUED WITH BT. 1422 PLACING ENRIQUE CARLO(OFFENDER) INTO CUSTODY AT 1707 N. KOSTNER. ALL THREE OFFENDERS WERE TRANSPORTED TO THE 014TH DISTRICT FOR PROCESSING. [REDACTED] WITH NO VISIBLE INJURIES WAS TRANSPORTED TO THE 014TH DISTRICT BY BT. 1461D. CFD AMBULANCE #62 WAS ON SCENE AT THE 014TH DISTRICT TO EXAMINE BOTH [REDACTED] AND JUSTIN TAYLOR(OFFENDER). AMBULANCE #62 DETERMINED NEITHER [REDACTED] OR TAYLOR NEEDED TO BE TAKEN TO THE HOSPITAL. [REDACTED] WAS TURNED OVER TO HER AUNT [REDACTED] WHO ARRIVED AT THE 014TH DISTRICT CONTACTED BY 1461C. NAME CHECK REVEALED ENRIQUE CARLO(OFFENDER) TO HAVE A SUSPENDED DRIVER'S LICENSE. ALL THREE OFFENDERS WERE MIRANDIZED BY R/O KHAN IN THE PRESENCE OF LARA WITH ENRIQUE CARLO(OFFENDER) AT 2118 HOURS, IGNACIO MUNGUIA(OFFENDER) AT 2122 HOURS, AND JUSTIN TAYLOR(OFFENDER) AT 2125 HOURS. POST MIRANDA BOTH ENRIQUE CARLO(OFFENDER) AND IGNACIO MUNGUIA(OFFENDER) INVOKED THEIR RIGHT TO REMAIN SILENT. POST MIRANDA JUSTIN TAYLOR(OFFENDER) STATED HE DIDN'T KNOW THAT THE VEHICLE WAS STOLEN AND THAT CARLO AND MUNGUIA WERE ALREADY TOGETHER WHEN THEY PICKED HIM UP. TRR'S COMPLETED BY LARA AND SGT. VALE. EVIDENCE TECHNICIAN ORDERED VIA CITYWIDE 2 TO DOCUMENT JUSTIN TAYLOR'S (OFFENDER) INJURIES. OWNER OF STOLEN VEHICLE [REDACTED] (VICTIM AND COMPLAINANT) ARRIVED AT THE 014TH DISTRICT TO SIGN COMPLAINTS. [REDACTED] (VICTIM AND COMPLAINANT) STATED HE DID NOT GIVE ANYONE PERMISSION TO ENTER, TAKE, OR REMAIN IN HIS VEHICLE. HOT DESK NOTIFIED AND BOTH PLATES CLEARED VIA LEADS (WALKER #20 AT 2150 HOURS) AND VEHICLE TURNED OVER TO [REDACTED] (VICTIM AND COMPLAINANT). CITATIONS ISSUED TO ENRIQUE CARLO(OFFENDER) TK-146-391, 392, 393, 394, 395, 396, AND 397. FELONY CHARGES SOUGHT VIA FELONY REVIEW. ASA S. ABRAHAM APPROVED FELONY CHARGES FOR ENRIQUE CARLO(OFFENDER) AT 0132 HOURS. ET QUINTANA #8741 (BT. 5813) ARRIVED AT THE 014TH DISTRICT TO PHOTOGRAPH JUSTIN TAYLOR(OFFENDER).
