NARRATIVE

EVENT#01404 IN SUMMARY, R/O NOWAK #12930 BEAT 395 WAS ASSIGNED TO COMPLETE A REPORT FOR AGGRAVATED BATTERY TO P.O.. BT 331 RELATED TO R/O THAT THEY ATTEMPTED TO CURB A VEHICLE FOR TRAFFIC OFFENSES (OVERTAKING VEHICLES ON THE RIGHT AND SQUEALING TIRES) AT WHICH POINT THE VEHICLE DISOBEYED BT 331'S ACTIVATED EMERGENCY EQUIPMENT AND THE VEHICLE FLED THROUGH THE ALLEY AND INTO A GARAGE. BT 331 P.O. JONAS EXITED HIS SQUAD CAR AND APPROACHED THE DRIVER-OFFENDER. THE OFFENDER IMMEDIATELY EXITED THE DRIVER'S SEAT AND BEGAN YELLING AT BT 331 IN SLURRED SPEECH. P.O. JONAS DETECTED A STRONG ODOR OF ALCOHOLIC BEVERAGE ON THE OFFENDER'S BREATH. P.O. JONAS OBSERVED THAT THE OFFENDER'S EYES WERE BLOODSHOT, GLASSY, AND WATERY. THE OFFENDER WAS THEN GIVEN A DIRECT VERBAL COMMAND BY P.O. JONAS TO PLACE HIS HANDS ON THE VEHICLE WHICH THE OFFENDER DISOBEYED. THE OFFENDER THEN BALLED UP BOTH FISTS, SWUNG HIS ARMS, AND STRUCK P.O. JONAS IN THE CHEST WITH HIS ELBOW AND ATTEMPTED TO PUSH PAST HIM. AS P.O. POLSON APPROACHED TO ASSIST, THE OFFENDER BALLED UP BOTH FISTS AND PUFFED UP HIS CHEST AND SAID "SHOOT ME". AS BT 331 ATTEMPTED TO PLACE THE OFFENDER IN CUSTODY THE OFFENDER CONTINUED TO DISREGARD VERBAL COMMANDS, PULLED AWAY BY TWISTING HIS BODY, AND SWUNG HIS ARMS AROUND STRIKING P.O. JONAS IN THE LEFT RIB CAGE. BT 331 PERFORMED AN EMERGENCY TAKEDOWN. WHILE TRYING TO CUFF OFFENDER ON THE GROUND, THE OFFENDER CONTINUED TO DISREGARD VERBAL COMMANDS AND RESISTED BY PULLING HIS HANDS UNDERNEATH HIS BODY, TWISTING HIS BODY, AND KICKING HIS LEGS. IN THE PROCESS THE OFFENDER PROCEEDED TO KICK P.O. POLSON IN THE LEFT LEG CAUSING PAIN AND SWELLING. THE OFFENDER CONTINUED TO DISREGARD DIRECT VERBAL COMMANDS AND CONTINUED TO STRUGGLE WITH BT 331 ATTEMPTING TO PULL AWAY AND DEFEAT THE ARREST. DURING THE STRUGGLE P.O. JONAS SUSTAINED INJURIES TO HIS RIGHT KNEE AND LEFT HAND AND LEFT HIP. THE OFFENDER ALSO SPIT ON P.O. JONAS STRIKING HIM IN THE VEST. BT 331 WAS ABLE TO PLACE THE OFFENDER INTO CUSTODY AND AWAITED BACKUP. THE OFFENDER CONTINUED TO KICK AND TWIST HIS BODY ATTEMPTING TO PULL HIS HANDS TO THE FRONT OF HIS BODY. BT 314 ARRIVED ON SCENE AND AS P.O. JUNG APPROACHED TO ASSIST, THE OFFENDER KICKED P.O. JUNG IN THE LOWER LEGS MULTIPLE TIMES CAUSING HIM TO FALL BACKWARDS ON HIS RIGHT ELBOW AND SUSTAIN LACERATIONS TO HIS RIGHT ARM. UPON GETTING UP P.O. JUNG WAS BLEEDING HEAVILY FROM HIS RIGHT ELBOW. THE OFFENDER ALSO KICKED P.O. POLSON IN THE LEFT ARM CAUSING PAIN. AS THE OFFENDER WAS BEING PLACED INTO THE BACK OF BT 314'S SQUAD CAR THE OFFENDER TWISTED AND LOCKING HIS ARMS AND CUFFED HANDS AROUND P.O. JUNG'S LEFT FOREARM CAUSING MULTIPLE ABRASIONS. THE OFFENDER WAS TRANSPORTED INTO 003 AND AMBULANCE 70 TRANSPORTED THE OFFENDER TO JACKSON PARK HOSPITAL FOR TREATMENT. BT 331 RELOCATED TO JACKSON PARK AND READ THE OFFENDER THE WARNING TO MOTORIST. THE OFFENDER CONTINUED TO STRUGGLE WITH HOSPITAL STAFF YELLING AND CAUSING A DISTURBANCE. P.O. JUNG, P.O. JONAS AND P.O. POLSON WENT TO NORTHWESTERN HOSPITAL TO RECIEVE TREATMENT FOR THEIR INJURIES. BT 5823 FOSTER#14410 PHOTOGRAPHED ALL INJURIES TO OFFICERS. P.O.'S WERE TREATED AND RELEASED BY DR. SHAKERI. P.O. JUNG RELATED TO R/O THAT HIS WOUND ON HIS RIGHT ELBOW RECEIVED TREATMENT. THE OFFENDER'S VEHICLE HAD THREE PASSENGERS, ([REDACTED]) THE PASSENGERS EXITED THE VEHICLE AFTER THE STOP AND ONE OF THE PASSENGERS MAY HAVE BEEN FILMING THE INCIDENT ON A CELLULAR PHONE. THE OFFENDER REFUSED CHEMICAL TESTING FOR DUI WHILE AT JACKSON PARK HOSPITAL. HOWEVER, THE OFFENDER'S BLOOD WAS DRAWN AT JACKSON PARK HOSPITAL DURING THE COURSE OF TREATMENT. BT 331 AND BT 314 IN-CAR CAMERA SYSTEMS WERE FILMING AT THE TIME OF THE INCIDENT AND A VIDEO HOLD REQUEST WAS SUBMITTED. SUPPLEMENTARY REPORT COMPLETED BY BT 312 ASSIGNED TO PRISONER DETAIL AT JACKSON PARK HOSPITAL DOCUMENTING THE OFFENDER'S ACTIONS. THE OFFENDER WAS MIRANDIZED AT 0748 HRS BY P.O. JONAS IN THE PRESENCE OF P.O. POLSON AND P.O. JUNG. POST MIRANDA THE OFFENDER STATED TO P.O. POLSON AND P.O. PENA "I DRANK A PINT OF HENNESSEY AND CRANBERRY JUICE...THEY WOULDN'T TELL ME WHY THEY PULLED ME OVER SO I RESISTED...THEY HAD ME ON THE GROUND SO I KEPT RESISTING...THEY DIDN'T TURN THEIR LIGHTS ON UNTIL I WAS IN MY GARAGE." BT 331 RECOVERED AN EMPTY BOTTLE OF STELLA ARTOIS BEER AND A HALF FULL 375 ML BOTTLE BACARDI RUM FROM THE INTERIOR OF THE VEHICLE.
