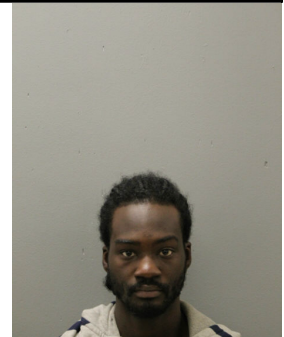

EV#05289, IN SUMMARY, FREEMAN, DEVON(OFFENDER) PLACED INTO CUSTODY AFTER FLEEING FROM A TRAFFIC STOP IN WHICH THE VEHICLE WAS CURBED FOR NO FRONT REGISTRATION [REDACTED]. FREEMAN, DEVON(OFFENDER) FLED FROM THE FRONT PASSENGER SEAT OF THE VEHICLE, WESTBOUND, HOLDING THE FRONT OF HIS WAISTBAND, A TACTIC A/OS KNOW FROM KNOWLEDGE AND EXPERIENCE TO BE COMMON FOR CONCEALING A WEAPON. A/O DONAHUE GAVE PURSUIT ON FOOT AND FREEMAN, DEVON(OFFENDER) WAS SUBSEQUENTLY FOUND HIDING IN BRUSH OF THE VACANT LOT OF THE ABOVE ADDRESS AND PLACED INTO CUSTODY BY A/O WILLIAMS ASSISTED BY A/O BURG. WHILE PLACING FREEMAN, DEVON(OFFENDER) INTO CUSTODY, A/OS OBSERVED (1) BLUE STEEL FIRE STAR-PLUS 9MM HANDGUN SERIAL #2193806 W/ LIVE ROUNDS APPROXIMATELY 12-18 INCHES FROM THE LOCATION FREEMAN, DEVON(OFFENDER) HEAD. FREEMAN, DEVON(OFFENDER) WAS TRANSPORTED TO AREA SOUTH BY BT 0733 FOR FURTHER INVESTIGATION AND DURING A CUSTODIAL SEARCH BY TRANSPORTING OFC CONNORS #15151, (1) HAND ROLLED CIGAR W/ GREEN LEAF SUBSTANCE SUSPECT CANNABIS AND (1) SMALL RED ZIPLOCK BAG CONTAINING GREEN LEAF SUBSTANCE SUSPECT CANNABIS WERE RECOVERED FROM FREEMAN, DEVON(OFFENDER) WAISTBAND AREA INV#13790581.
