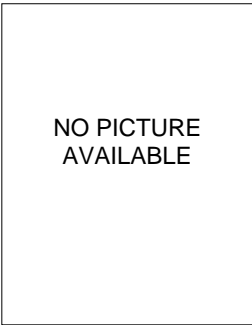

EVENT#01131 COURT KEY(K) R/O'S RESPONDED TO A SUSPICIOUS PERSON CALL AT ABOVE LOCTION. UPON ARRIVAL R/O'S SPOKE WITH [REDACTED] (VICTIM AND COMPLAINANT) WHO STATED ANDY JARDINAS(OFFENDER) BROKE THE REAR WINDOW OF HIS RESIDENCE. OFF WAS STILL ON SCENE AND PLACED IN CUSTODY . OFF WAS INTOXICATED AND SUSPECTED TO HAVE USED OTHER DRUGS. R/O'S REQUESTED EMS AND AMBULANCE #69 TRANSPORTED OFF TO SAINT ANTHONY HOSPITAL WHERE HE WAS TREATED AND RELEASED. WHILE HE WAS UNDER THE CARE OF ST. ANTHONY'S, THE OFF WAS OBSERVED STRIKING HIS HEAD AGAINST THE HOSPITAL WALL. VICTIM SIGNED COMPLAINTS AND WAS GIVEN VIN WITH COURT INFORMTION. BWC WORN AND ACTIVATED. UPON RETURN FROM ST ANTHONY'S, IN THE PROCESSING AREA IN THE 009TH DIST, POST ARREST R/O'S PLACED (OFFENDER) IN HOLDING CELL (A) HANDCUFFED BEHIND HIS BACK DURING THIS INCIDENT BODY CAMERAS WERE NO LONGER RECORDING. R/O'S THEN OBSERVED ANDY JARDINAS(OFFENDER) HANDCUFFED FROM THE FRONT.(OFFENDER)WAS OBSERVED USING THE HANDCUFFS TO HIT THE GLASS FROM HOLDING CELL (A) HITTING IT MULTIPLE TIMES CAUSING THE GLASS TO SHATTER. AS P.O CORONA OPENED THE CELL DOOR IN ORDER TO STOP OFF FROM BREAKING THE GLASS, ANDY JARDINAS(OFFENDER) THEN STEPPED TOWARDS P.O CORONA IN AN AGGRESSIVE MANNER WHILE RAISING HIS HANDS PLACING P.O CORONA IN REASONABLE APPREHENSION OF RECIEVING A BATTERY. P.O CORONA REACTED BY PUSHING OFFENDER AWAY FROM HIM CAUSING OFF TO FALL BACKWARDS AND STRIKING HIS HEAD ON THE FLOOR. OFFENDER SUSTAINED A LUMP TO THE BACK OF HIS HEAD. AMB19 TRANSPORTED OFF TO MERCY HOSP FOR TREATMENT. NAME CHK CLR/NOINV ALERTS. NOT ON PROBATION OR PAROLE. CLR GIPP. NO GANG CARD ON CLEAR. DENIES GANG AFFILIATION. TRR COMPLETED.
