	<p>EVENT#09626 A/O'S HAD OPERATING BODY CAMERA'S AT TIME OF ARREST. IN SUMMARY A/O'S RESPONDED TO A PERSON SHOT AT 10331 S. CRANDON UPON ARRIVAL A/O'S LEARNED FROM VICTIM (OFF DUTY POLICE OFFICER GAINES #6030) THAT ARRESTEE POINTED A GUN AT HIM AT WHICH TIME A STRUGGLE ENSUED BETWEEN PO GAINES AND THE OFFENDER DURING THE STRUGGLE PO GAINES DISCHARGED HIS GUN AT THE OFFENDER. THE VICTIM FURTHER RELATED TO R/O'S THAT THE OFFENDER THEN DROPPED HIS GUN FLED. PO GAINES RECOVERED OFFENDER'S DROPPED WEAPON AND GAVE CHASE AFTER OFFENDER. PO GAINES CHASED OFFENDER AND OBSERVED HIM ENTER THE HOUSE LOCATED AT 10331 S. CRANDON. A/O'S SET UP A PERIMETER, OEMC RELATED TO A/O'S THAT OFFENDER WANTED TO COME OUT OF THE HOUSE AND SURRENDER BUT PHYSICALLY COULD NOT DUE TO EXHAUSTION AND TROUBLE WITH HIS ASTHMA. A/O'S MADE ENTRY INTO THE HOUSE AND OFFENDER WAS TO THE RIGHT, INSIDE OF THE FRONT DOOR, OFFENDER IMMEDIATELY PLACED INTO CUSTODY WITHOUT INCIDENT BY PO MCCANN #12030.
