(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)
 EVENT #14953 THE ABOVE LISTED ARRESTEE WAS PLACED INTO CUSTODY AFTER POINTING A FIREARM AT A/O CERVANTES #14881 ON SCENE OF A CALL OF A ROBBERY IN PROGRESS. A/O CERVANTES GAVE THE ARRESTEE VERBAL DIRECTION TO DROP SAID FIREARM. THE ARRESTEE FAILED TO COMPLY WITH A/O CERVANTES' LAWFUL ORDER AND IN FEAR OF BEING SHOT BY THE ARRESTEE, WHO WAS POINTING HIS HANDGUN AT HIM, A/O CERVANTES DISCHARGED HIS FIREARM STRIKING THE ARRESTEE. A/O CERVANTES THEN DISARMED THE ARRESTEE AND ATTEMPTED TO PLACE HIM INTO CUSTODY. THE ARRESTEE BEGAN TO PULL AWAY FROM A/O CERVANTES AND ASSISTING UNITS. THE ARRESTEE WAS THEN PLACED INTO CUSTODY AND TRANSPORTED TO STROGER HOSPITAL VIA CFD AMBULANCE 15. WHILE AT STROGER HOSPITAL CFD AMB 15 PARAMEDIC RELATED TO BT 1532 A/O PILOLLI #16870 THEY HAD RECOVERED THREE ZIP-LOCK BAGS FROM THE ARRESTEE DURING TRANSPORT. A/O PILOLLI RECOVERED SAID ITEMS WHICH WERE FOUND TO CONTAIN A WET PLANTLIKE SUBSTANCE SUSPECT PCP LACED MATERIAL (INV. #13786405). THE ARRESTEE HAS \$202.01 USC.

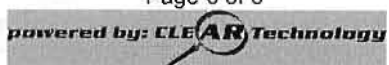
