R/O FIRED UPON OFFENDER AFTER BEING CONFRONTED DURING ARMED ROBBERY INVESTIGATION WHEN OFFENDER WHO WAS ARMED WITH A HANDGUN POINTED SAME AT R/O AND IGNORED VERBAL COMMANDS TO DROP THE WEAPON. AFTER R/O FIRED ON AND STRUCK OFFENDER, THE OFFENDER REFUSED TO DROP WEAPON AND R/O USED HIS FIREARM AS AN IMPACT WEAPON TO DISLODGE HANDGUN FROM THE OFFENDERS GRIP. SUBJECT WAS THEN TAKEN INTO CUSTODY WITH THE ASSISTANCE OF PARTNER AND ASSISTING UNITS.
