GSW #1 enter left abdomen, exit upper right back.  
 GSW #2 enter outer side of right shoulder, exit top of right shoulder.  
 GSW #3 to upper right chest, lodged.  
 GSW #4 to right groin, lodged.  
 GSW #5 to back of left thigh, lodged.  
 GSW #6 to right lower back, lodged.  
 Graze wounds to outer right forearm and top of head.

INTERNAL EXAMINATION:

Three (3) medium caliber copper jacketed projectiles and several fragments, recovered.
