NARRATIVE

EVT.#14138, IN SUMMARY, RASHEE GRANT(OFFENDER), ARRESTED IN THAT A/O'S KNOWING OFFENDER TO BE A CONVICTED FELON FOR NARCOTICS OBSERVED SUBJECT LOITERING ON THE CORNER OF PAULINA AND JONQUIL, WHICH IS KNOWN TO BE A HIGH NARCOTIC AREA. A/O'S PULLED UP IN THEIR UNMARKED SQUAD CAR TO SPEAK TO RASHEE GRANT(OFFENDER), AT WHICH TIME A/O'S NOTICED WHAT APPEARED TO BE A BLACK HANDLE OF A HAND GUN PROTRUDING FROM OFFENDER'S RIGHT PANTS POCKET. A/O'S EXITED THE VEHICLE, AT WHICH TIME OFFENDER STATED "NOT TODAY" AND FLED ON FOOT WHILE HOLDING HIS WAIST BAND E/B ON JONQUIL THEN N/B THROUGH THE EAST ALLEY OF PAULINA. A/O'S GAVE CHASE AT WHICH TIME OFFENDER FELL TO THE GROUND ONCE IN THE ALLEY AND THEN JUMPED THROUGH THE FENCE AT 7731 N. PAULINA. A/O BRANNIGAN CONDUCTED A EMERGENCY TAKE DOWN AT WHICH TIME OFFENDER SPONTANEOUSLY UTTERED "I HAVE A GUN IN MY POCKET." A/O'S PLACED OFFENDER IN CUSTODY AND A/O BRANNIGAN RECOVERED FROM RASHEE GRANT(OFFENDER), RIGHT FRONT PANTS POCKET, ONE BLACK FEG-MODEL PA-63, SERIAL #HB8406, 3INCH BARREL, SEMI-AUTOMATIC HANDGUN. RASHEE GRANT(OFFENDER)TRANSPORTED TO 024 FOR PROCESSING. COURT INFO BR.42-4,18NOV16.
