#### ARREST REPORTING

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event #02141, In summary A/O's were responding to shots fired in the vacinity of 120th St and LaSalle St. observed offender now known as Dwane Rowlett driving east bound fail to use turn signal when turning and fail to stop at a stop sign while operating above listed vehicle at the intersection of 120th St and State St. A/O's activated their emergency lights and attempted to curb listed vehicle. Offender pulled the vehicle off too the side of the road and made an evasive maneuver at which time offender then drove the vehicle up onto the west sidewalk of State street and proceeded to drive south on the side walk at a high rate of speed falling to stop at 2 stop signs and a solid red signal light placing other motorists in fear for their safety. At the intersection of 125th and State the above listed vehicle tried to re-enter traffic at which time striking a vehicle in traffic on State street at 125th St. The listed vehicle lost control and struck a parked vehicle, the offender then crashed the vehicle at which time A/O Fennell ordered the offender to exit the vehicle. Offender refused to comply with A/O Fennell and A/O Bogyo verbal directions and stiffened his body while reaching towards his right-side thereby placing the officers in fear of a battery. Offender taken into custody and transported to Christ Hospital by CFD #5 for injuries he sustained from the incident, Upon receiving treatment at Christ Hospital, Mr. Rowlett was found to have a blood serum of .94. Officer Curia#8019 went to the hospital and read Mr. Rowlett his Warning to Motorist at 7:44 a.m. The Dui kit(INV#13828884) was completed by . 
