A/O's observed above Ofdr. fleeing on foot E/B on Madison towards Homan. Believing subject was involved in the shots fired A/O's initiated a foot pursuit. During foot pursuit Ofdr. JOHNSON retrieved a firearm from his waistband area and pointed at A/O Collazo #4679. A/O Collazo in fear of his life discharged his weapon, striking Ofdr. JOHNSON (3) times. Ofdr. transported to Mt. Sinai by CFD.
