DURING THE PRELIMINARY INVESTIGATION, IT WAS DETERMINED THAT VICTIM#1 [REDACTED] (VICTIM AND COMPLAINANT) SUSTAINED ONE GSW TO THE CHEST, VICTIM#1 WAS TRANSPORTED BY CFD#10 TO COOK COUNTY STROGER HOSPITAL, PER DR. [REDACTED] VICTIM#1 IS IN FAIR CONDITION, VICTIM#2 [REDACTED] (VICTIM AND COMPLAINANT) SUSTAINED GSW GRAZE WOUND TO THE UPPER LEFT THIGH, VICTIM#2 WALKED INTO MT. SINAI, PER DR. [REDACTED] VICTIM#2 STABLE CONDITION, VICTIM#3 [REDACTED] (VICTIM AND COMPLAINANT) SUSTAINED ONE GSW TO THE BUTTOCKS, VICTIM#3 WALKED INTO MT. SINAI, PER DR. [REDACTED] VICTIM#3 IN STABLE CONDITION.
