NARRATIVES

EVENT # 15034 COURT KEY "W" IN UNIFORM/UNMARKED FORD EXPLORER. IN SUMMARY, R/O'S RESPONDED TO AN ASSIST CALL FROM BEAT 0863E AT 6700 S CLAREMONT. UPON ARRIVAL R/O'S OBSERVED PO DURKIN AND PO CAVALLONE AND 0863D STRUGGLING WITH THE OFFENDER ON THE GROUND. R/O'S ASKED FOR A TAZER BECAUSE THE SUBJECT REFUSED TO REMOVE HIS HANDS FROM UNDERNEATH HIS BODY AFTER BEING TOLD NUMEROUS TIMES AND PO GLIM #15597 DEPLOYED HIS TAZER AFTER VERBAL WARNINGS TO THE OFFENDER. THE TAZER DID NOT SEEM TO HAVE AN EFFECT ON THE OFFENDER. THE OFFENDER THEN ATTEMPTED TO KICK PO GLIM AT WHICH TIME PO GLIM DRIVE STUNED THE OFFENDER ON THE BACK. R/O'S WERE ABLE TO HANDCUFF AND LEG SHAKLE THE OFFENDER AFTER SEVERAL MINUTES OF STRUGGLING ON THE STREET. R/O'S CALLED FOR AND CFD AMBULANCE FOR THE OFFENDER BECAUSE OF THE TAZER DEPLOYMENT AND ABRASIONS TO THE SUBJECTS FACE FROM THE PAVEMENT. CFD AMB # 58 ARRIVED ON SCENE AND R/O'S CARRIED THE OFFENDER TO THE AMBULANCE AND THE OFFENDER WAS TAKEN TO HOLY CROSS HOSPITAL FOR TREATMENT. WHILE AT THE HOSPITAL THE SUBJECT AGAIN REFUSED TO PUT HIS HANDS INTO RESTRAINTS AFTER THE HANDCUFFS WERE REMOVED. THE OFFENDER WAS TOLD SEVERAL TIMES BY R/O'S AND HOSPITAL STAFF TO COMPLY AND THE SUBJECT KEPT STRUGGLING. THE OFFENDER THEN ATTEMPTED TO KICK PO GLIM AND THE HOSPITAL STAFF AT WHICH TIME PO GLIM DRIVE STUNNED THE OFFENDER WITH HIS TAZER IN THE RIGHT THIGH AND THE OFFENDER EVENTUALLY COMPLIED TO BEING



NARRATIVES

RESTRAINED BY THE FEET AND HANDS BY HOSPITAL STAFF. WHILE AT THE HOSPITAL PO DURKIN AND PO CAVALLONE (0863E) RELATED TO R/O'S THE FOLLOWING. A/O'S RESPONDED TO A SHOTS FIRED CALL IN THE AREA OF 6600 SOUTH FAIRFIELD. UPON TOURING THE AREA A/O'S OBSERVED ABOVE VEHICLE (FORD WINDSTAR) STOPPED AT RED LIGHT FACING EASTBOUND AT 2401 WEST MARQUETTE RD. A/O'S OBSERVED RIGHT REAR TAIL TO BE INOPERABLE AND FURTHER OBSERVED ABOVE FORD WINDSTAR START TO TURN NORTH FROM THE CENTER LANE BUT STOP AND FACE EASTBOUND AGAIN ONCE A/O'S PULLED BEHIND IT. A/O'S RAN PLATE VIA LEADS WHICH REVEALED VEHICLE REGISTERED TO 6538 S WASHTEAW, LESS THAN ONE BLOCK FROM WHERE SHOTS FIRED CALL WAS GIVEN OUT. A/O'S ACTIVATED THEIR EMERGENCY EQUIPMENT TO WHICH ABOVE FORD WINDSTAR TRAVELED FOR ONE BLOCK AND PULLED TO THE LEFT WHERE VEHICLE CURBED. A/O'S DURKIN/CAVALLONE OBSERVED ABOVE OFFENDER MOVING HIS BODY TO THE LEFT, RIGHT AND DOWN TOWARDS THE FLOOR. A/O'S APPROACHED ABOVE VEHICLE AND ASKED ABOVE OFFENDER (DRIVER) FOR A VALID DRIVERS LICENSE TO WHICH HE STATED HE DIDNT HAVE HIS LICENSE BUT RATHER PRODUCED AN ILLINOIS STATE ID. A/O DURKIN RETURNED TO HIS POLICE VEHICLE, RAN ID WHICH REVEALED ABOVE OFFENDER TO BE CURRENTLY ON PAROLE. A/O DURKIN RETURNED TO FORD WINDSTAR AND ASKED ABOVE OFFENDER WHAT HE WAS ON PAROLE FOR TO WHICH ABOVE OFFENDER STATED ARMED ROBBERY, ALL THE WHILE ABOVE OFFENDER CONTINUED TO MOVE HIS RIGHT HAND TOWARDS THE CENTER CONSOLE OF VEHICLE WHERE A/O DURKIN COULD NOT SEE IT. A/O DURKIN ASKED ABOVE OFFENDER TO EXIT VEHICLE WHICH HE COMPLIED. AS A/O DURKIN HELD ON TO ABOVE OFFENDER'S CLOTHING, A/O CAVALLONE STARTED TO SEARCH VEHICLE TO WHICH ABOVE OFFENDER FLED ON FOOT. WITH A/O DURKIN STILL HOLDING ONTO ABOVE OFFENDER'S CLOTHING, ABOVE OFFENDER TURNED TO HIS RIGHT AND GAVE A/O DURKIN A ROUNDHOUSE PUNCH WITH THE BACK OF HIS RIGHT FIST MISSING A/O DURKIN. A/O CAVALLONE THEN ASSISTED IN THE STRUGGLE AND ABOVE OFFENDER GAVE A/O CAVALLONE SEVERAL KNEE STRIKES TO THE CHEST WHILE ATTEMPTING TO PERFORM AN EMRGENCY TAKEDOWN. A/O DURKIN AND A/O CAVALLONE EVENTUALLY PERFORMED AN EMERGENCY TAKE DOWN. WHILE STRUGGLING ON THE GROUND ABOVE OFFENDER ATTEMPTED TO BITE A/O CAVALLONE, MISSING HIM. ABOVE OFFENDER THEN WHILE ON THE GROUND KICKED BACKWARDS AT A/O CAVALLONE STRIKING HIM IN THE LOWER BODY. A/O CAVALLONE WAS ABLE TO RADIO FOR ASSIST CARS. ONCE BACKUP ARRIVED, R/O GLIM #15597 TASERED ABOVE OFFENDER, AFTER ABOVE OFFENDER ATTEMPTED TO KICK R/O GLIM 15597. ONCE PLACING ABOVE OFFENDER INTO CUSTODY A/O CAVALLONE RECOVERED FROM LEFT PANT POCKET OF ABOVE OFFENDER (1) OPENED DORITOS CHIP BAG CONTAINING INSIDE (23) KNOTTED PLASTIC BAGGIES EACH CONTAINING WHITE ROCK LIKE SUBSTANCE SUSPECT CRACK COCAINE AND (7) ZIP LOCK BAGGIES EACH CONTAINING GREEN PLANT LIKE SUBSTANCE SUSPECT CANNABIS. AMBULANCE TRANSPORTED ABOVE OFFENDER TO HOLY CROSS HOSPITAL FROM THE SCENE OF ARREST. A/O'S DURKIN AND CAVALLONE TRANSPORTED THEMSELVES FOR TREATMENT OF LACERATIONS AND ABRASIONS TO KNEES AND HANDS. X-RAYS REVEALED BRUISING AND BUILD UP OF FLUID ON THE RIGHT KNEE OF A/O DURKIN, LACERATIONS AND ABRASIONS TO HIS LEFT HAND AND A/O CAVALLONE RECEIVED SEVERAL LACERATIONS TO BOTH OF HIS HANDS AND ABRASIONS TO BOTH KNEES. OFFENDER IS CURRENTLY IN CUSTODY AT HOLY CROSS HOSPITAL IN BED #18. E.T. 5843 ARRIVED AT HOLY CROSS HOSPITAL TO PHOTOGRAPH THE OFFENDER AND P.O. CAVALLONES' INJURIES AND P.O. DURKINS INJURIES. DURING THE COURSE OF THE ARREST THE CHICAGO POLICE PATCH ON P.O. CAVALLONES LEFT SHOULDER WAS RIPPED OFF CAUSING A TEAR IN THE SLEEVE OF THE UNIFORM SHIRT. BEAT #5125 DETECTIVE ANDERSON ARRIVED IN THE 008TH DISTRICT TO SEEK CHARGES FOR AGG BATT TO P.O. ON BEHALF OF P.O. CAVALLONE. ASA MITROVIC APPROVED CHARGES AT 0250FOR (1) COUNT OFF AGG BATT TO P.O. OFFENDER IS ALSO BEING CHARGED WITH (2) COUNTS OF RESISTING, (3) COUNTS OF AGG ASSAULT, (1) CRIMINAL DAMAGE TO PROPERTY. OFFENDER ALSO RECIEVED (6) TRAFFIC CITATIONS. COURT DATE IS 17JAN17 AT 1300, 48-4.
