INVESTIGATION:  
The reporting detective (R/D) was acting as the required blind administrator as requested by Detective TAKAKI #20824, the assigned investigator. Detective P. STAUNTON #21111 assembled the above described photo line-up which was comprised of (6) photographs, (2) horizontal rows each containing (3) images, on a single page. Det. STAUNTON then provided this photo line-up to R/D.

The reporting detective responded to Mt. Sinai Hospital and was introduced to [REDACTED] by Detective J.C. MORALES #20741. R/D then presented a Photo Line-up Advisory Form to [REDACTED] which he signed after R/D assisted him with reading the instructions. [REDACTED] declined to be videotaped or audio recorded as he viewed the array and signed the appropriate areas on the form to indicate these choices.

Upon viewing the photo line-up, [REDACTED] identified Herbert JOHNSON in position #2 and stated "Number two looks like the guy who shot me".
