INCIDENT NARRATIVE	<p>(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)</p> <p>Event #19125 In summary, The above subject was the front seat passenger of a blue 1980 Pontiac Trans Am, which pulled up to the curb at 1030 n rush. The subject exited the vehicle and removed a white plastic bag containing a partially consumed 40oz container of Budweiser beer, which he concealed behind a concrete construction barrier,. subject was taken into custody for obstructing beat 1884's investigation by removing the item from the vehicle in an attempt to conceal it. subject transported to the 018th district for processing at that time. upon arrival in the station, beat 1891 entered a holding cell to conduct a custodial search and as he entered, the subject kicked an open door closed, causing it to strike beat 1891's right hand, causing a contusion. subject then struck beat 1891 on the head with a closed fist, making physical contact, at which time beat 1891 struck him in the face with a closed fist to force him to cease his aggressive actions and to overcome his resistance to control. subject sustained lacerations to his face and was transported to Prentice Hospital, where he was treated and released. Name check clear, no wants, investigative alerts, not on parole or in violation of bail bond. Subject had a non-serviceable traffic warrant from Boone County, Ill. Subject is GIPP clear, no gang affiliations, and 2 degrees of Association clear. While being treated at St. Mary's Hospital, subject made verbal threats toward P.O. Matson Holmes stating that he would 'beat his ass and bash his head in' placing P.O. Holmes in reasonable apprehension of receiving a battery.</p>
