INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)
 EVENT # 09851 IN SUMMARY, ON THE ABOVE DATE AND TIME R/OS RESPONDED TO ABOVE LOCATION FOR HOLDING OFFENDER CALL. COMPLAINANT [REDACTED] RELATED TO R/OS THAT OFFENDER HAD PASSED THE LAST POINT OF SALE CONCEALING ITEMS, AT WHICH TIME HE WAS DETAINED UNTIL R/OS ARRIVAL FOR RETAIL THEFT. UPON ARRIVING TO TAKE OFFENDER INTO CUSTODY UNDER SIGNED COMPLAINTS, OFFENDER BROKE FREE FROM P.O. GIESEL #19481 AND P.O. KOCH #7536 AND BEGAN TO FLEE IN AN ATTEMPT TO DEFEAT THE ARREST. OFFENDER REFUSED TO FOLLOW MULTIPLE VERBAL COMMANDS FOR OFFENDER TO STOP FLEEING WHILE P.O. KOCH #7536 GAVE CHASE. [REDACTED] WAS ABLE TO GRAB OFFENDER AND SLOW HIM DOWN LONG ENOUGH FOR P.O. KOCH #7536 TO PERFORM EMERGENCY TAKEDOWN AND HANDCUFFING ON OFFENDER. OFFENDER AGAIN REFUSED TO FOLLOW MULTIPLE VERBAL COMMANDS TO PLACE HIS HANDS BEHIND HIS BACK, STIFFENING, DEADWEIGHTING HIS BODY ON TOP OF HIS HANDS, CAUSING P.O. KOCH#7536 TO PERFORM AN ARMBAR AND WRISTLOCK ON OFFENDER IN ORDER TO TAKE OFFENDER INTO CUSTODY. OFFENDER PUT INTO ESCORT HOLD AND PLACED INTO R/O'S VEHICLE. DURING THE TAKEDOWN, P.O. KOCH'S RIGHT SIDE OF FACE/EYE MADE CONTACT WITH EDGE OF WALL INSIDE WALMART, RESULTING IN A FACIAL LACERATION/SWELLING TO THE RIGHT SIDE OF P.O. KOCH #7536'S FACE, WHICH REQUIRED MEDICAL ATTENTION/HOSPITALIZATION. R/OS ARE UNABLE TO POSITIVELY IDENTIFY OFFENDER VIA SOS, LEADS AND I-CLEAR. OFFENDER ALLEGES A KNEE INJURY, NO VISIBLE INJURIES SEEN AT THIS TIME. OFFENDER WAS TAKEN TO MERCY HOSPITAL BY 223 AND TREATED BY A PHYSICIAN. OFFENDER HAS NO USC ON HIS PERSON. NAME CHECK ON INFORMATION PROVIDED CLEAR.
