NARRATIVE

E# 14500 IN SUMMARY R/SGT RESPONDED TO A TASER DEPLOYMENT. ON SCENE R/SGT SPOKE WITH P.O. DJORDEVIC #19065 AND P.O. ALVEAR #14141. THE OFFICERS STATED THEY WERE ON SCENE FOR A WANTED PERSON UNDER RD HZ218148 FOR RETAIL THEFT. THEY APPROACHED THE OFFENDER MICHAEL STEWART IN THE PARKING LOT AND EXPLAINED TO HIM THAT HE WAS UNDER ARREST. THE OFFENDER REACHED INTO HIS PANTS AND BEGAN REMOVING A LONG OBJECT. P.O. DJORDEVIC #1906, IN FEAR THAT THE OFFENDER WAS REMOVING A HANDGUN, DREW HIS GUN ON THE OFFENDER. P.O. DJORDEVIC #1906 THEN SAW THAT THE OFFENDER HAD A CHISEL HAMMER AND THE OFFENDER BEGAN BACKING AWAY AND SWINGING. P.O. DJORDEVIC #1906 THEN REHOLSTERED HIS GUN AND DREW HIS TASER AND GAVE VERBAL COMMANDS. MICHAEL STEWART(OFFENDER) FLED WHILE STILL WAVING THE CHISEL HAMMER. P.O. DJORDEVIC #1906, STILL USING VERBAL COMMANDS, GAVE CHASE AND DEPLOYED A TASER WITH NO AFFECT. A SECOND DEPLOYMENT KNOCKED THE OFFENDER DOWN WHERE HE STRUCK HIS LEFT EYE ON THE STREET RECEIVING A LACERATION. HE WAS PLACED IN CUSTODY FOR RETAIL THEFT AND AGGRAVATED ASSAULT. AMBULANCE 30 TRANSPORTED HIM TO ST. BERNARD UNDER THE CARE OF DR. MOON. HE WAS TREATED AND RELEASED WITH 4 STITCHES. R/SGT AND OFFICERS WERE ONLY ABLE TO RECOVER THREE OF THE FOUR PRONGS. THE TASER CARTRIDGES AND TASER DOWNLOAD SHEET WERE INVENTORIED UNDER #13708197. IPRA LOG # OBTAINED 1081017.
