INCIDENT NARRATIVE

Event#19125 Summary: The above subject was observed pulling his vehicle, a blue 1980 Pontiac Trans Am, up to the curb at the listed location. The subject, who was seated in the driver's seat, with the engine on and the key in the ignition, was then further observed drinking from a 40oz bottle of Budweiser beer. Subject exited the vehicle at which time beat 1884 approached the subject for a field interview and identified himself as a Chicago Police Sergeant. Beat 1884 ordered the subject to produce a drivers license and proof of insurance, but subject refused to comply and attempted to walk away. The subject was told he was being placed under arrest for DUI and stated "Fuck you, come here!" The subject then bladed his body in a fighting stance and balled up his fists in a threatening manner, placing beat 1884 in reasonable apprehension of receiving a battery. The subject was approached with assisting units to affect the arrest at which time the subject locked his arms together in front of his body, stiffened his body and then began to pull his arms away. The subject was placed into custody and continued resisting by not walking to vehicle and refused to enter same. The subject was partially inside the vehicle and began flailing his body which caused him to fall between the seat and the divider causing a minor injury to his right ear. The subject was eventually transported into the 018th district by beat 1872R. A name check while in the 018th Dist revealed that the subject had a revoked drivers license for a previous DUI. Upon arrival in the station, subject read the warning to motorist from a preprinted formset, but refused to submit to sfst's and chemical testing. The subject was taken to Illinois Masonic for his injuries, where he became belligerent to the hospital staff and refused to cooperate or be treated, he was then relocated to St. Joseph's Hospital. Name check clear, no wants, investigative alerts, not on parole or in violation of bail bond. Subject had a non-serviceable traffic warrant from Boone County, Ill. Subject is GIPP clear, no gang affiliations, and 2 degrees of Association clear. Prisoner personal property inventoried under #13250739 and partially consumed 40oz. beer bottle inventoried under #13250753.
