NARRATIVE

(EVENT #09851) IN SUMMARY, RO'S RESPONDED TO A RETAIL THEFT CALL AT FIRM WALMART (VICTIM). RO'S MET WITH [REDACTED] (COMPLAINANT), WHO RELATED THAT SHE WITNESSED RICKY SEALES(OFFENDER) PLACE 3 DEODORANT ITEMS IN HIS JACKET AND THEN PLACE 3 DOVE BARS OF SOAP IN HIS PANTS. [REDACTED] (COMPLAINANT) THEN RELATED RICKY SEALES(OFFENDER) PROCEEDED PAST THE LAST POINT OF PURCHASE AND WAS SUBSEQUENTLY PLACED INTO TEMPORARY CUSTODY. [REDACTED] (COMPLAINANT) RELATED THAT SHE WANTED TO SIGN COMPLAINTS IN THE NAME OF WALMART. AT THIS TIME AO'S ATTEMPTED TO PLACE RICKY SEALES(OFFENDER) INTO CUSTODY ON SIGNED COMPLAINTS AND OFFENDER ATTEMPTED TO FLEE THE STORE BY RUNNING ON FOOT. AO'S PURSUED RICKY SEALES(OFFENDER) WHILE GIVING VERBAL COMMANDS TO STOP AT WHICH OFFENDER REFUSED. CONTACT WAS MADE ALONG WITH WITH [REDACTED] [REDACTED] INSIDE THE STORE. AO KOCH PERFORMED AN EMERGENCY TAKEDOWN OF THE OFFENDER AT WHICH TIME OFFENDER REFUSED MULTIPLE VERBAL COMMANDS TO PLACE HIS ARMS BEHIND HIS BACK WHILE STIFFENING UP HIS ARMS AND DEADWEIGHTING HIS BODY ON TOP OF HIS HANDS. THIS CAUSED OFFICER KOCH #7536 TO PERFORM AN ARMBAR AND WRIST LOCK ON OFFENDER IN ORDER TO PLACE OFFENDER IN CUSTODY. SUBSEQUENTLY OFFICER GIESEL PLACED THE OFFENDER IN HANDCUFFS AND OFFENDER WAS PLACED INTO CUSTODY AND PUT IN VEHICLE. DURING THE EMERGENCY TAKEDOWN, OFFICER KOCH'S RIGHT EYE MADE CONTACT WITH EDGE OF THE WALL. INJURIES SUSTAINED INCLUDED A LACERATION TO THE RIGHT EYE AS WELL AS BRUISING, SWELLING, AND REDNESSTO THE RIGHT EYE/RIGHT SIDE OF FACE. OFFICER KOCH IS SEEKING TREATMENT AT THE UNIVERSITY OF CHICAGO HOSPITAL . RICKY SEALES(OFFENDER) WAS THEN TRANSPORTED TO DISTRICT 002 FOR FURTHER PROCESSING. WHILE IN CUSTODY, RICKY SEALES(OFFENDER) RELATED THAT HIS KNEE WAS HURT AND HE REQUIRED MEDICAL ATTENTION. BEAT 223 TRANSPORTED RICKY SEALES(OFFENDER) TO MERCY HOSPITAL. AO'S WERE UNABLE TO POSITIVELY IDENTIFY OFFENDER VIA LEADS/CLEAR WITH THE INFORMATION RICKY SEALES(OFFENDER) PROVIDED. RICKY SEALES(OFFENDER) PROVIDED DIFFERENT NAMES FOR AO'S. NO FELONY CHARGES PURSUED DUE TO NOT BEING ABLE TO POSITIVELY VERIFY IDENTIFICATION. EVIDENCE TECHNICIAN FRANKS #14426 BEAT 5826 TOOK PICTURES OF OFFICER KOCH'S EYE AT 1820 HOURS. WALMART RECEIPTS AND VIDEO OF EMERGENCY TAKEDOWN INVENTORIED UNDER #13674528 .COURT INFORMATION: 34-5 AT 1430 HOURS 27MAY16.
