EVENT#01394. IN SUMMARY, A/O'S RESPONDED TO AN ASSAULT IN PROGRESS AT ABOVE ADDRESS OF LOCATION. R/O APPROACHED OFFENDER TO INVESTIGATE THE NATURE OF THE CALL AT WHICH TIME THE OFFENDER STATED "I'LL KICK YOUR BITCH ASS, SO GET THE FUCK OUT OF HERE, FUCK YOU WHITE CRACKERS, FUCK THESE CRACKERS". P.O. FERGUS WAS IN FEAR OF RECEIVING A BATTERY AT WHICH TIME THE OFFENDER STRUCK P.O. FERGUS WITH A CLOSED FIST THROUGH THE FENCE STRIKING HIM ABOUT THE FACE. ABOVE OFFENDER THEN FLED INSIDE THE RESIDENCE OF 1537 N. TALMAN. A HOT PURSUIT AND A FORCED ENTRY WAS MADE. AS P.O. FERGUS TRIED TO PLACE OFFENDER INTO CUSTODY HE RESISTED ARREST BY FLAILING HIS ARMS AND TRYING TO MOVE AWAY. AT THIS TIME P.O. FERGUS PERFORMED AN EMERGENCY TAKE DOWN ONTO A COUCH. P.O FERGUS ALONG WITH P.O. MENDOZA BROUGHT OFFENDER OUTSIDE ON THE FRONT LAWN WHERE OFFENDER THEN KICKED P.O. FERGUS IN THE CHEST. TRANSPORTED TO 014 FOR PROCESSING AND TREATED AT NORWEGIAN HOSPITAL BY DR. OYASU. NAME CHECK CLEAR PER DW/LEADS.
