INVESTIGATION:

R/D was assigned to handle the Aggravated Battery to four Police Officers with four offenders in custody in the 014th District by Sgt. Holy #2525 of this command on 01Jun2014 @ 0840 hours. R/D was told that all the victims and offenders were coming into the area for the investigation.

All interviews and statements in this report should be considered a summary of events and not verbatim unless otherwise noted.

INTERVIEW: Acuna, Romulo by Det. Weitzman #20307 014th District

Offender Romulo was given his Miranda Rights by Det. Weitzman at 0900 hours. Romulo acknowledged his rights and invoked

his right to have a lawyer present during questioning.

INTERVIEW: Rodriguez, Oscar by Det. Weltzman #20307 014th District

Offender Oscar was given his Miranda Rights by Det. Weitzman at 0915 hours. Oscar acknowledged his rights and invoked his right to have a lawyer present during questioning.

INTERVIEW: Rodriquez, Luis by Det. Weitzman #20307 019th District

Offender Luis was given his Miranda Rights by Det. Weltzman at 0940 hours. Luis acknowledged his rights and invoked his right to have a lawyer present during questioning.

INTERVIEW: Rodriguez, Cruz by Det. Weitzman #20307 Thorek Hospital

Offender Cruz was given his Miranda Rights by Det. Weitzman at 1005 hours. Cruz acknowledged his rights and invoked his right to have a lawyer present during questioning.

INTERVIEW: P.O. Mike Fergus #17370 at Area North 1010 hours

R/O stated that he responded to an assault in progress call. Upon arrival several people were yelling things such as, "You Motherfuckers. You can't come in. Fuck You. Get the Fuck out of here. Fuck these crackers. Call OPS." Most of these statements came from Luis, Oscar, and Romulo.

Luis and Oscar said, "I'll kick your Bitch Ass!" As P.O. Fergus was at the gate, which was locked to prevent the officers from gaining entry, talking to Romulo attempting to diffuse the situation, someone punching P.O. Fergus in the face.

P.O. Ridge had told P.O. Fergus that the offender Oscar had punched him in the right side of the face. There were no visible marks at the time of interview which was several hours after the incident.

Everyone then ran inside the house. Officers called for back up and when assist cars arrived officers gained access into the house. Offender Oscar's mother was blocking the entrance into the house. Officers moved her out of the way and Offender Cruz (Luis' Father) was holding him to prevent offender Luis from being arrested.

A/O's were able to apprehend offender Luis. Offender Luis was taken to the ground and handcuffed. P.O. Fergus escorted offender Luis outside at which time offender Luis kicked P.O. Fergus in the chest.

INTERVIEW: P.O. Scott Konior #14328 at Area North at 1030 hours

- P.O. Konior said that he was responding to a call for assisting an officer. P.O. Fergus said that someone had punched him in the face. P.O. Konior asked where the offender was. P.O. Fergus told P.O. Konior that the offender was in the house.
- P.O. Konior hopped the fence and gained entry into the house. P.O. Konior said that the offender's mother was standing in the doorway and she was moved out of the way.

Offender Cruz was holding Offender Luis in an attempt to keep Luis from being arrested. P.O. Konior asked Offender Cruz to release Offender Luis. P.O. Konior said, "Let's do this the easy way. Luis is going to Jall either way!"

As A/O's were pulling offender Luis from offender Cruz, offender Cruz grabbed P.O. Konior by the vest and pulled him to the ground sideways, falling into a TV.

- P.O. Konior attempted to get up and offender Cruz pulled P.O. Konior back to the ground and attempted to and hit and stuck P.O. Konior in the chest several times with a closed fist.
- P.O. Konior used several open hand strikes to offender Cruz's face, handcuffed him. The entire time that P.O. Konior was attempting to handcuff offender Cruz, he was resisting arrest avoiding being handcuffed.
- P.O. Konior then observed offender Romulo run at and strike P.O. Smith in the head and P.O. Smith went down to the ground.
- P.O. Konior had no visible marks at the time of interview which was several hours after the incident. P.O. Konior did complain of soreness.

CLEAR TEXABORE

INTERVIEW: P.O. Chad Smith #6021 at Area North at 1100 hours

- P.O. Smith stated that he responded to an assist the police call and observed a lot of people in the yard yelling obscenities and things such as, "Fuck You. Get out of here. They didn't do anything. You are all a bunch of bitches!"
- P.O. Smith observed and officer gain entry into the building and upon entry P.O. Smith observed P.O. Konlor was on the ground struggling with offender Cruz.
- P.O. Smith observed a large amount of people and was attempting to maintain control in the crowd when offender Romulo ran at him and punched P.O. Smith in the left side of the face causing him to fall backwards into a TV and then the TV fell on P.O. Smith's head.

Offender Romulo came charging at him and P.O. Luis Reyes #15014 grabbed offender Romulo. They placed offender Romulo on a sofa and attempted to handcuff offender Romulo who was resisting arrest by stiffening his arms.

Offender Romulo finally was subdued and handcuffed after some strikes to the head.

P.O. Smith sustained scrapes to his left forearm, left hand, and web of thumb. P.O. Smith also had Redness to left side of face. P.O. Smith had a bump on his head as well.

Beat 5836: E.T. Guitierrez #11666 took photo's of these injuries.

INTERVIEW: P.O. Marty Ridge #7538 at Area North at 1120 hours

- P.O. Ridge stated that he responded to an assault call and they locked the gate and started motherfucking them (officers). They started yelling, "Fuck You! I'll kill you! You Crackers! Call OPS."
- P.O. Ridge then observed offender Luis punch P.O. Fergus in the face. P.O. Ridge called for back up, stating that Mike was punched in the face.

When backup arrived Luis ran into the house. A/O's climbed the fence and gained entry into the house. Offender Cruz was holding Offender Luis in an attempt to defeat his arrest. Offender was arrested and taken out by P.O. Ridge and escorted to the wagon.

P.O. Ridge received no injuries and did not observe anything further.
