OFFENDER THEN SCRATCHED VICTIM/PO ARCHULETA IN THE FACE AND NECK CAUSING ABRASIONS, ALL IN AN ATTEMPT TO DEFEAT A LAWFUL ARREST. A/O'S HAD TO USE VERBAL COMMANDS, ESCORT HOLDS, AND DIRECT MECHANICAL STUNS WITH A CPD RADIO IN ORDER TO DEFEAT THE ASSAILANT'S ATTACK AND PLACE HIM INTO CUSTODY. THE OFFENDER THEN SPIT SALIVA AND BLOOD AT PO/VICTIM KOCIOLEK INTENTIONALLY AS HE WAS ATTEMPTING TO TAKE THE OFFENDER TO CFD AMBULANCE #43. VICTIMS WERE TREATED AND RELEASED AT ILLINOIS MASONIC HOSPITAL FOR ABOVE INJURIES BY DR. ORTEGA. ABOVE OFFENDER WAS ALSO TAKEN TO ILLINOIS MASONIC HOSPITAL FOR TREATMENT BY CFD AMBULANCE #43.
