<b>INCIDENT NARRATIVE</b>	(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following) EVENT #01759 ABOVE OFFENDER PLACED IN CUSTODY ON SIGNED COMPLAINTS IN THAT HE ENTERED THE BUILDING LOCATED AT 1333 N CLEVELAND AVE AFTER RECIEVEING PRIOR NOTICE THAT HE WAS BARRED FROM THE PREMISES. WHILE AT THE ABOVE LOCATION, OFFENDER THREATENED ██████████ STATING, "I'LL BEAT YOUR FUCKING ASS BITCH", PLACING THE VICTIM IN FEAR OF RECIEVING A BATTERY. AS R/O'S ATTEMPTED TO PLACE THE OFFENDER IN CUSTODY, OFFENDER STRUCK PO/VICTIM BAKER IN HIS RIGHT EYE CAUSING BLUNT TRAUMA AND BLURRED VISION. OFFENDER THEN SCRATCHED VICTIM/PO ARCHULETA IN THE FACE AND NECK CAUSING ABRASIONS, ALL IN AN ATTEMPT TO DEFEAT A LAWFUL ARREST. A/O'S HAD TO USE VERBAL COMMANDS, ESCORT HOLDS, AND DIRECT MECHANICAL STUNS WITH A CPD RADIO IN ORDER TO DEFEAT THE ASSAILANT'S ATTACK AND PLACE HIM INTO CUSTODY. THE OFFENDER THEN SPIT SALIVA AND BLOOD AT PO/VICTIM KOCIOLEK INTENTIONALLY AS HE WAS ATTEMPTING TO TAKE THE OFFENDER TO CFD AMBULANCE #43. VICTIMS WERE TREATED AND RELEASED AT ILLINOIS MASONIC HOSPITAL FOR ABOVE INJURIES BY DR. ORTEGA. ABOVE OFFENDER WAS ALSO TAKEN TO ILLINOIS MASONIC HOSPITAL FOR TREATMENT BY CFD AMBULANCE #43.
