EV#15411 IN SUMMARY R/O'S OBSERVED A SILVER DODGE CHARGER BEARING ILLINOIS PLATE [REDACTED] EXP 03/2017 WITH NO PLATE LIGHT MAKE A RIGHT TURN FAILING TO USE A TURN SIGNAL. R/O'S ACTIVATED THEIR EMERGENCY EQUIPMENT AND CURBED THE VEHICLE AT 8701 S. KING DR. AS R/O'S APPROACHED THE VEHICLE R/O ROSILES #19462 COULD SMELL THE ODOR OF BURNT CANNABIS EMANATING FROM THE VEHICLE. R/O ROSILES #19462 APPROACHED THE DRIVER'S SIDE WINDOW AND ASKED THE DRIVER OF THE VEHICLE (NOW KNOWN AS COREY WILLIAMS(OFFENDER) FOR A VALID DRIVERS LICENSE AND PROOF OF INSURANCE. COREY WILLIAMS(OFFENDER) THEN ASKED R/O ROSILES #19462 NOT VERBATIM WHY HE WAS BEING PULLED OVER TO WHICH R/O ROSILES #19462 STATED THE REASONS OF NO PLATE LIGHT AND FAILING TO USE A TURN SIGNAL AND AGAIN ASKED FOR A VALID DRIVER'S LICENSE AND PROOF OF INSURANCE WITH COREY WILLIAMS(OFFENDER) NEVER PRODUCING A VALID LICENSE OR PROOF OF INSURANCE. COREY WILLIAMS(OFFENDER) THEN BECAME AGITATED AND AGGRESSIVE TOWARDS R/O'S AND TURNED HIS VEHICLE OFF MAKING MOVEMENTS TOWARDS THE DRIVER'S SIDE DOOR TO WHICH THEN R/O'S ASKED COREY WILLIAMS(OFFENDER) TO EXIT THE VEHICLE IN ORDER TO BE PLACED INTO CUSTODY FOR UNABLE TO PRODUCE A VALID DRIVER'S LICENSE AND INSURANCE. R/O ROSILES #19462 THEN ATTEMPTED TO PLACE THE OFFENDER INTO CUSTODY AT WHICH TIME COREY WILLIAMS(OFFENDER) ABRUPTLY TURNED AROUND IN AN AGGRESSIVE MANNER IN AN ATTEMPT TO DEFEAT R/O'S ARREST WHICH LED R/O'S TO BELIEVE HE MAY HAVE BEEN TRYING TO CONCEAL A WEAPON. R/O'S THEN ATTEMPTED TO GAIN COMPLIANCE OF COREY WILLIAMS(OFFENDER) AT WHICH TIME COREY WILLIAMS(OFFENDER) STIFFENED LEADING R/O'S TO CONDUCT A WRIST LOCK, EMERGENCY TAKEDOWN, AND EMERGENCY HANDCUFFING. ONCE IN CUSTODY ALL FORCE STOPPED AND R/O ROSILES #19462 CONDUCTED A CUSTODIAL SEARCH OF COREY WILLIAMS(OFFENDER) WITH NEGATIVE RESULTS OF A WEAPON. R/O RANGEL #5339 CONDUCTED A NARCOTICS INVESTIGATION DUE TO THE SMELL OF BURNT CANNABIS EMANATING FROM THE VEHICLE AND FOUND ONE SMALL CLEAR ZIPLOCK BAGGIE CONTAINING A GREEN LEAFY SUBSTANCE SUSPECT CANNABIS IN THE CENTER CONSOLE OF THE VEHICLE. COREY WILLIAMS(OFFENDER) WAS THEN TRANSPORTED TO THE 006TH DISTRICT FOR FURTHER PROCESSING. IN THE 006TH DISTRICT, COREY WILLIAMS(OFFENDER) ALLEGED THAT HIS ELBOW WAS HURTING AND WAS ASKED IF HE NEEDED ANY MEDICAL ASSISTANCE TO WHICH THEN THE OFFENDER REFUSED ANY MEDICAL TREATMENT. COREY WILLIAMS(OFFENDER) ALSO THEN STRIPPED DOWN TO HIS SHORTS WITHOUT BEING TOLD TO DO SO AND WAS ASKED MULTIPLE TIMES BY R/O ROSILES #19462 AND R/O RANGEL #5339 TO PUT HIS CLOTHES ON AND REFUSED. TRAFFIC CITATIONS ISSUED UNDER TN-048-684,685,686, AND 687. TRR'S COMPLETED. EVENT WAS RECORDED ON R/O'S BWC. CANNABIS INVENTORIED UNDER INV#13807645.
