 EVENT #04478 ADDRESS OF ARREST: 354 N CICERO. IN SUMMARY R/OS AND SGT ROLON #1014 BT#1150 RESPONDED TO DISTURBANCE - MENTAL AT DUNKIN DONUTS, LOCATED AT CTA GREEN LINE CICERO STOP, AT 4758 W. LAKE ST WHERE OFFENDER WAS OBSERVED INSIDE CTA VESTIBULE SCREAMING AT AND CHASING CTA PATRONS. OFFENDER EXITED ONTO SIDEWALK AND STARTED YELLING UNINTELLIGIBLY AT SGT ROLON #1014 AS WELL AS TALKING TO HIMSELF. BT#1172 ARRIVED ON SCENE. OFFENDER THEN PICKED UP A LARGE GLASS BOTTLE AND RAISED IT ABOVE HIS HEAD IN A THREATENING MANNER PLACING SGT ROLON #1014 REASONABLE APPREHENSION OF RECEIVING A BATTERY. OFFENDER TRANSPORTED TO LORETTO HOSPITAL BY CFD AMB. #23 FOR TREATMENT OF INJURIES AND ██████████ BY SGT ROLON #1014.
