ROLON #1014 RESPONDED TO AN OEMC ASSIGNMENT OF DISTURBANCE WITH A MENTAL - SUBJECT COMING BEHIND THE COUNTER REFUSING TO LEAVE AND "PUNCHING AT THE WALLS" AT THE DUNKIN DONUTS/CTA GREEN LINE LOCATED AT 4758 W. LAKE ST. UPON ARRIVAL R/O'S OBSERVED DELBERT MATTOX(OFFENDER) INSIDE THE VESTIBULE OF THE CTA SCREAMING AT, AND CHASING CTA PATRONS. DELBERT MATTOX(OFFENDER) THEN EXITED THE CTA PROPERTY ONTO THE SIDEWALK AND STARTED YELLING UNINTELLIGIBLY AT BEAT 1150, SGT. R. ROLON #1014, R/O'S THEN OBSERVED DELBERT MATTOX(OFFENDER) TALKING TO HIMSELF. R/O'S THEN OBSERVED DELBERT MATTOX(OFFENDER) PICK UP A LARGE GLASS BOTTLE, RAISE IT ABOVE HIS HEAD IN A THREATENING AND OFFENSIVE MANNER, THEREBY PLACING SGT. R. ROLON #1014, BEAT 1150 IN FEAR OF RECEIVING A BATTERY. DELBERT MATTOX(OFFENDER) THEN FLED</p>

NORTHBOUND ON CICERO ST. R/O L. MAXWELL #19422, THEN PURSUED DELBERT MATTOX(OFFENDER) ON FOOT IN ORDER TO PLACE THE OFFENDER INTO CUSTODY AND ORDERED DELBERT MATTOX(OFFENDER) TO STOP. DELBERT MATTOX(OFFENDER) REFUSED AND CONTINUED TO RUN N/B ON CICERO IN AN EFFORT TO DEFEAT THE ARREST, R/O L. MAXWELL #19422 THEN VERBALLY NOTIFIED DELBERT MATTOX(OFFENDER) THAT IF HE DID NOT STOP HE WOULD BE TASERED, BUT DELBERT MATTOX(OFFENDER) CONTINUED TO FLEE N/B. R/O L. MAXWELL #19422, BELIEVING THE OFFENDER TO BE A THREAT TO THE PHYSICAL SAFETY OF NEARBY CITIZENS THEN DEPLOYED HIS TASER, CAUSING DELBERT MATTOX(OFFENDER) TO FALL FACE-FORWARD ONTO THE STREET PAVEMENT AND SUSTAIN A BLEEDING INJURY TO THE HEAD AND A LACERATION OVER THE RIGHT EYE. R/O L. MAXWELL #19422 THEN HANDCUFFED DELBERT MATTOX(OFFENDER) AND IMMEDIATELY REQUESTED AN AMBULANCE AND CFD AMB.# 23 ARRIVED ON SCENE AND TRANSPORTED DELBERT MATTOX(OFFENDER) TO LORETTO HOSPITAL WHERE HE WAS TREATED BY DR. LOIS CLARK WHO LISTED HIM IN SERIOUS CONDITION WITH A LACERATION OVER THE RIGHT EYE, AND POSSIBLE INTERNAL BLEEDING INSIDE OF THE HEAD. THE NIECE OF DELBERT MATTOX(OFFENDER) ARRIVED AT HOSPITAL AND RELAYED TO BEAT 1112 THAT [REDACTED] OCIC REQUESTED BY BT 1150 VIA CPIC, MOOREHEAD #6612, AT 1209 HRS.
