(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT#15384 IN SUMMARY, SEVERAL INDIVIDUALS WERE OBSERVED DRINKING ALCOHOLIC BEVERAGES IN THE CITY PARK. OFFICER CABRALES #19023 AND PHILLIPS #16006 APPROACHED TO CONDUCT A FIELD INVESTIGATION. AT WHICH TIME, THE OFFICERS OBSERVED A FIREARM FALL TO THE GROUND, AND THEN OBSERVED THE OFFENDER ATTEMPT TO CONCEAL THE FIREARM WITH A RAG WHILE PICKING IT UP AND ATTEMPTING TO FLEE. OFFICER CABRALES GRAB A HOLD OF THE OFFENDER'S SHIRT AS HE ATTEMPTED TO FLEE AND FAIL TO ADHERE TO VERBAL DIRECTIONS. OFFENDER DID THEN POINT THE FIREARM, WHICH WAS IN HIS RIGHT HAND, AT OFFICER CABRALES. OFFICER CABRALES IN FEAR OF HIS LIFE THEN DISCHARGED HIS SERVICE WEAPON (1) TIME AT THE OFFENDER STRIKING HIM IN THE HEAD AREA. OFFENDER WAS PLACED INTO CUSTODY AND EMS REQUESTED. THE FIREARM WAS IMMEDIATELY RECOVERED AND FOUND TO BE LOADED W/ (1) ROUND IN THE CHAMBER. FURTHER INVESTIGATION REVEALED OFFENDER IS A CONVICTED FELON UNDER [REDACTED] FOR AGGRAVATED ROBBERY. NAME CHECK CLEAR. ABOVE HAS NO WARRANTS, NO ALERTS, IS NOT ON GIPP, TRAP, OR PAROLE.
