INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event #18801, In summary, AOs responded to a call of a 10-1 shots fired at the police at 4740 N. Hamlin where there was also a large fist fight. AOs monitored a flash message describing the offenders as several male Hispanics fleeing westbound. A loaded handgun was recovered. Gomez was observed running westbound and detained by beat 1761a. Officer Mendoza arrived on-scene and positively identified offender Gomez as first being involved in the large fist fight on the public way at 4740 N Hamlin, then fleeing the scene, jumping through multiple yards resulting in multiple foot chases which resulted in multiple vehicles having to make emergency stops, two officers being hospitalized elevated blood pressure and put officers and citizens alike in fear for their safety. ROs assigned to transport Gomez to area north by on-scene supervisor. Further investigation by detectives revealed co-arrestee [REDACTED] was the offender to be charged with the weapons violations. Name check clear.
