NARRATIVES

EVT# 12336 ? IN SUMMARY, WHILE ON PATROL ON THE 700 BLOCK OF NORTH ST. LOUIS, A LOCATION KNOWN FOR HIGH LEVELS OF ILLEGAL NARCOTICS SALES, R/O'S OBSERVED BRANDON TATE(OFFENDER) ENGAGE IN A HAND-TO-HAND TRANSACTION WITH AN UNK M/1. BELIEVING BRANDON TATE(OFFENDER) AND THE UNK M/1 ENGAGED IN AN ILLEGAL NARCOTICS TRANSACTION FROM R/O'S KNOWLEDGE OF THE HEAVY NARCOTIC SALES OCCURRING IN THE AREA AND PRIOR ARRESTS FOR NARCOTICS RELATED OFFENSES, R/O'S APPROACHED IN THEIR VEHICLE TO CONDUCT A FIELD INTERVIEW AND OBSERVED THE TWO SUBJECTS THEN WALK AWAY FROM EACH OTHER. AS R/O'S APPROACHED BRANDON TATE(OFFENDER) IN THEIR PATROL VEHICLE, R/O'S OBSERVED PAPER USC IN BRANDON TATE'S (OFFENDER) HAND AND ASKED BRANDON TATE(OFFENDER) OVER TO THEIR VEHICLE FOR A FIELD INTERVIEW AT WHICH TIME BRANDON TATE(OFFENDER) LOOKED IN THEIR DIRECTION AND FLED ON FOOT. R/O'S GAVE CHASE IN THE PATROL VEHICLE AND P.O. CONNER GAVE CHASE ON FOOT AS BRANDON TATE(OFFENDER) FLED EAST THROUGH THE YARDS TOWARD TRUMBULL AND JUMPED SEVERAL FENCES WHILE FLEEING. AS R/O WAS DRIVING SOUTH ON TRUMBULL, BRANDON TATE(OFFENDER) RAN INTO THE STREET AT 732 N. TRUMBULL AND RAN INTO THE PATROL VEHICLE ON THE FRONT RIGHT QUARTER PANEL. BRANDON TATE(OFFENDER) FELL TO THE GROUND, STOOD UP, AND RAN NORTH A SHORT DISTANCE BEFORE FALLING TO THE GROUND AGAIN. R/O'S EXITED THE PATROL VEHICLE AND APPROACHED TO DETAIN BRANDON TATE(OFFENDER). AT THIS TIME, P.O. HANEY #3591 OBSERVED BRANDON TATE(OFFENDER) STUFF A PIECE OF CLEAR PLASTIC CONTAINING SMALL WHITE ITEMS, CONSISTENT WITH NARCOTICS PACKAGING FOR HEROIN, INTO A MANHOLE COVER/ SEWER LOCATED APPROXIMATELY 10-15 FEET BEHIND R/O'S PATROL VEHICLE. BRANDON TATE(OFFENDER) WAS DETAINED AT WHICH TIME BRANDON TATE(OFFENDER) RELATED TO R/O'S THAT HIS LEG WAS HURT. R/O'S IMMEDIATELY CALLED FOR AN AMBULANCE VIA OEMC. THE SUBJECT WAS TRANSPORTED TO STROGER HOSPITAL FOR TREATMENT BY CFD AMB#45. DR. JOSEPH WAS THE ATTENDING PHYSICIAN. AFTER ENSURING THAT THE ABOVE INDIVIDUAL RECEIVED MEDICAL ATTENTION, R/O'S ATTEMPTED TO OBTAIN THE SUSPECT NARCOTICS THAT BRANDON TATE(OFFENDER) STUFFED INTO THE SEWER BY REMOVING THE MANHOLE COVER BUT THE SUSPECT NARCOTICS HAD WASHED AWAY IN FLOWING WATER. R/O'S DID NOT CHARGE BRANDON TATE(OFFENDER) WITH ANY NARCOTICS RELATED OFFENSE DUE TO THE UNSUCCESSFUL RECOVERY OF THE SAID CLEAR PLASTIC BAG CONTAINING THE SUSPECT HEROIN. R/O'S NOTIFIED THEIR IMMEDIATE SUPERVISOR 1165 SERGEANT REYKJALIN #2290. BEAT 1121 WAS ASSIGNED TO INVESTIGATE THE TRAFFIC ACCIDENT AND RESPONDED TO STROGER HOSPITAL ER BED 3, WHICH WAS DOCUMENTED UNDER RD#HZ431458. THROUGH BEAT 1121'S INVESTIGATION OF THE TRAFFIC ACCIDENT, THE OFFENDER WAS CITED FOR A VIOLATION OF 625 ILCS 5/11-1003(A): PEDESTRIAN CROSSING ROADWAY OUTSIDE THE CROSSWAY UNDER CITATION #TK-293-612. PER BEAT 1121, BRANDON TATE(OFFENDER) SUSTAINED COMMUNUTED FRACTURE TO LEFT TIBIA AND FIBULA PER DR. JOSEPH AT STROGER HOSPITAL. BRANDON TATE(OFFENDER) WAS FOUND TO BE WEARING AN ELECTRONIC MONITORING BRACELET ON HIS ANKLE. A NAME CHECK OF THE SUBJECT REVEALED THE SUBJECT TO BE ON PAROLE WITH AN ALIAS BIRTHDAY OF 30 DEC 93. POD FOOTAGE REQUESTED FROM POD 5050 LOCATED AT 3425 W. CHICAGO AND POD 4060 LOCATED AT 700 N. TRUMBULL FROM 1730-1740HRS. ET ORDERED BY BEAT 1165 TO TAKE PHOTOGRAPHS OF R/O'S VEHICLE AND OF BRANDON TATE'S (OFFENDER) INJURIES. BEAT 5834 ET GODINEZ #17273 ASSIGNED.
