EVENT #09032 ***BODY WORN CAMERA ACTIVE*** IN SUMMARY, R/O'S OBSERVED A SILVER VOLVO OPERATING WITH EXPIRED ILLINOIS TEMPORARY PLATES [REDACTED]. R/O'S CONDUCTED A TRAFFIC STOP ON THE VEHICLE. R/O GARBACZ #17624 APPROACHED THE VEHICLE AND REQUESTED [REDACTED] (OFFENDER/DRIVER) LICENSE AND INSURANCE. THE OFFENDER PROVIDED VALID INSURANCE AND A NEW JERSEY AUTO DRIVER LICENSE [REDACTED]. UPON RUNNING THE NEW JERSEY LICENSE NUMBER ON THE PDT LEADS CAME BACK WITH NO RECORD ON FILE. R/O'S ATTEMPTED TO RUN THE OFFENDER'S NAME THROUGH LEADS ON THE PDT BUT STILL CAME BACK WITH NO RECORD ON FILE. AT THIS TIME R/O ZAMOJSKA #8309 ATTEMPTED TO OBTAIN ANOTHER FORM OF IDENTIFICATION FOR THE OFFENDER. WHEN THE OFFENDER COULD NOT PROVIDE ANY FURTHER INFORMATION ON HIS IDENTIFICATION R/O ZAMOJSKA HAD THE OFFENDER STEP OUT OF THE VEHICLE. WHEN THE OFFENDER STEPPED OUT OF THE VEHICLE HE BEGAN MOVING HIS HANDS TOWARDS HIS WAISTBAND MAKING R/O'S BELIEVE HE MAY BE CONCEALING SOMETHING IN HIS WAISTBAND. AS R/O ZAMOJSKA ATTEMPTED TO PLACE THE OFFENDER IN CUSTODY FOR NO VALID DRIVER'S LICENSE THE OFFENDER BEGAN TO FLEE ON FOOT. DURING THE PURSUIT OFFENDER CONTINUELY PLACED HIS HANDS NEAR HIS WAISTBAND. R/O'S PURSUED THE OFFENDER ON FOOT WESTBOUND ON 79TH ST AT WHICH TIME THE OFFENDER TURNED NORTHBOUND ON FOOT ON THE 7800 BLOCK OF LANGLEY THEN BEGAN RUNNING WESTBOUND THROUGH THE ALLEY. R/O GARBACZ BRIEFLY LOST SIGHT OF THE OFFENDER BETWEEN THE TIME HE TURNED WESTBOUND IN THE ALLEY TO THE TIME HE TURNED NORTHBOUND. R/O GARBACZ OBSERVED THE OFFENDER TURN AND BEGIN RUNNING NORTHBOUND IN THE ALLEY BETWEEN CHAMPLAIN AND LANGLEY. R/O GARBACZ BEGAN SEARCHING THE YARD OF 7841 S CHAMPLAIN WHEN SHE

NARRATIVES

OBSERVED THE OFFENDER LAYING DOWN AT THE BOTTOM OF THE STAIRS. R/O GARBACZ INSTRUCTED THE OFFENDER TO PUT HIS HANDS IN THE AIR AND BEGAN TO WALK UP THE STAIRS TO REMOVE THE OFFENDER FROM A TIGHT AND SMALL LOCATION. AS THE OFFENDER BEGAN COMING UP THE STAIRS TOWARDS R/O GARBACZ THE OFFENDER CONTINUED PLACING HIS HANDS BACK IN HIS POCKETS R/O GARBACZ INSTRUCTED THE OFFENDER TO PUT HIS HANDS IN THE AIR TO PROVIDE WARNING PRIOR TO THE USE OF FORCE. WHEN THE OFFENDER REACHED THE TOP OF THE STAIRS R/O GARBACZ HAD THE OFFENDER TURN AWAY FROM HER TO CREATE MORE DISTANCE BETWEEN THE OFFENDER AND HERSELF. AS R/O GARBACZ WAITED FOR MORE UNITS TO ARRIVE ON SCENE TO STABILIZE THE SITUATION THROUGH USE OF TIME THE OFFENDER CONTINUED TO PLACE HIS HANDS IN HIS POCKET. R/O GARBACZ INSTRUCTED THE OFFENDER TO KEEP HIS HANDS IN THE AIR MULTIPLE TIMES AND AS THE OFFENDER BEGAN TO MOVE TOWARD THE FENCE (SECURED/HELD TOGETHER WITH A BIKE LOCK) R/O GARBACZ INFORMED HIM SHE WOULD DEPLOY THE TASER. THE OFFENDER THAN GRABBED THE FENCE TO ATTEMPT TO CLIMB THE FENCE AT WHICH POINT R/O GARBACZ ANNOUNCED "TASER, TASER" IN ACCORDANCE WITH DEPARTMENT POLICY. AFTER ANNOUNCING "TASER, TASER" THE OFFENDER HAD REACHED THE FENCE ATTEMPTING TO CLIMB OVER THE TOP AND OFFICER GARBACZ DISCHARGED HER TASER IMMEDIATELY AFTER ANNOUNCING "TASER, TASER." THE OFFENDER WAS ON THE GROUND ON THE OTHER SIDE OF THE FENCE WHEN OFFICER DEYOUNG #17199 ARRIVED ON SCENE. THE OFFENDER BEGAN TO STAND UP ATTEMPTING TO CONTINUE TO FLEE AGAIN. AT THIS TIME OFFICER DEYOUNG PERFORMED AN EMERGENCY TAKEDOWN AND PULLED THE OFFENDER'S RIGHT ARM FROM UNDERNEATH HIS BODY. THROUGHOUT THIS TIME OFFICER DEYOUNG WAS SHOUTING VERBAL COMMANDS TO THE OFFENDER TO PUT HIS HANDS BEHIND HIS BACK. THE OFFENDER CONTINUED TO RESIST OFFICER DEYOUNG AND WOULD NOT LISTEN TO NUMEROUS VERBAL COMMANDS. OFFICER DEYOUNG WAS ABLE TO FREE THE OFFENDER'S RIGHT HAND AND GAIN CONTROL IN ORDER THAT OFFICER CASSASANTO #14360 COULD PLACE HANDCUFFS ON THE OFFENDER AND THE ARREST COULD BE MADE. OFFICER DEYOUNG USED HIS KNEE AND HAND TO APPLY PRESSURE TO PRESSURE SENSITIVE AREAS TO GAIN COMPLIANCE FROM THE OFFENDER. OFFICERS WERE FINALLY ABLE TO APPREHEND THE OFFENDER AND ESCORT THE OFFENDER TO A MARKED SQUAD CAR WHILE USING A WRISTLOCK. R/O'S CALLED FOR EMS FOR THE OFFENDER. BEAT 605 FOLLOWING THE PATH THE OFFENDER FLED FOUND AT THE LOCATION OF 650 E 79TH ST, WHERE R/O GARBACZ BRIEFLY LOST SITE OF THE OFFENDER, A CLEAR PLASTIC BAG CONTAINING 17 CLEAR BAGS OF GREEN LEAFY SUBSTANCE SUSPECT CANNABIS. THE OFFENDER WAS TAKEN BY AMB 55 TO JACKSON PARK HOSPITAL UNDER DR. EGGENBEEN AND LATER TRANSPORTED TO STROGER HOSPITAL. WHILE R/O GARBACZ WAS ATTEMPTING TO GO UNDER THE FENCE TO ASSIST OFFICER DEYOUNG HER BODY WORN CAMERA WAS CAUGHT ON THE FENCE AND BROKE OFF THE CAMERA HOLSTER. ET WAS ORDERED AT 2115HRS FOR OFFICER DEYOUNG AFTER COMPLETING AN IOD REPORT AND TO PROCESS THE SCENE.
