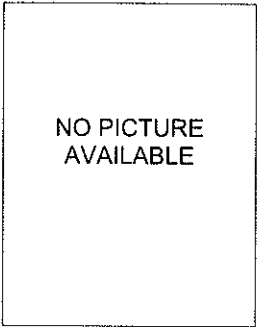

EVENT: 12641. THIS IS AN AUDIO AND VIDEO RECORDED ARREST BY BT0263A. ABOVE OFFENDER PLACED IN CUSTODY AFTER BEING POSITIVELY IDENTIFIED AS THE OFFENDER WHO ,WHILE ARMED WITH A H & R .22 CALIBER BLUE STEEL REVOLVER SERIAL #AU047515 MODEL 929 APPROACHED THE VICTIM, POINTED HIS GUN AT THE VICTIM, AND DEMANDED THE VICTIM'S VEHICLE. THE VICTIM, A CHICAGO POLICE OFFICER, IN DEFENSE OF HIS LIFE DISCHARGED ONE ROUND AT THE OFFENDER, WHO SUSTAINED A GUNSHOT WOUND IN LOWER RIGHT ABDOMEN. THE OFFENDER DROPPED HIS HANDGUN WHICH WAS IMMEDIATELY SECURED BY THE VICTIM. A SECOND OFFENDER FLED THE SCENE ON FOOT. ARRESTEE SEARCHED AND TRANSPORTED TO NORTHWESTERN HOSPITAL BY AMBULANCE 4.
