(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)
 EV #13472: PURSUANT TO A/O'S TRAFFIC STOP FOR A CANNABIS INVESTIGATION, THE OFFENDER NOW KNOWN AS JERMARIE WHITE, WAS OBSERVED INSIDE THE VEHICLE, REACHING DOWN TOWARDS HIS BOOT. ON MULTIPLE OCCASSIONS, P.O. BARONA #16054, INSTRUCTED WHITE TO STOP REACHING INTO HIS BOOT. DUE TO THE FAILURE TO COMPLY WITH VERBAL DIECTIONS, THE OFFENDER WAS REMOVED FROM THE VEHICLE. UPON EXITING THE VEHICLE, OFFENDER WHITE STRUCK P.O. BARNES #13912 IN HIS CHEST CAUSING P.O. BARNES #16054 IN PURSUIT. WHITE CONTINUED TO DISREGARD VERBAL COMMANDS TO STOP AND SHOW HIS HANDS. P.O. BARONA #16054 NEVER LOST SIGHT OF WHITE, WHO SECRETED HIMSELF UNDERNEATH A SET OF SEMI-TRUCK TRAILERS. IN A POORLY LIT AREA, WHILE WHITE WAS FACING P.O. BARONA #16054, WHITE CONTINUED TO DISREGARD NUMEROUS VERBAL COMMANDS TO STOP REACHING INTO HIS BOOT. WHITE'S ACTIONS OF REFUSAL TO OBEY NUMEROUS VERBAL COMMANDS, BATTERY TO POLICE OFFICER BARNES #13912, HIS FLIGHT FROM THE VEHICLE, ALONG WITH HIS CONTINUED REFUSAL TO OBEY VERBAL COMMANDS TO STOP REACHING INTO HIS BOOT, PLACED P.O. BARONA #16054, IN FEAR OF BEING SHOT BY OFFENDER WHITE P.O. BARONA #16054 DISCHARGE HIS WEAPON STRIKING THE OFFENDER. UPON ARREST, WHITE WAS SEARCHED AND A CLEAR KNOTTED BAG CONTAINING A WHITE CHUNKY SUBSTANCE, SUSPECT CRACK COCAINE WAS RECOVERED FROM WHITE'S RIGHT BOOT. NOT ON GIPP/TRAPP/NO INV ALERTS/NO WANTS OR WARRANTS/ GD GANG CARD/ UNK AMOUNT OF USC/NO PROBATION OR PAROLE/ NO BWC. THE OFFENDER TRANSPORTED TO COOK COUNTY HOSPITAL FOR TREATMENT. P.O. BARONA #16054 WAS TRANSPORTED TO RUSH FOR TREATMENT.
