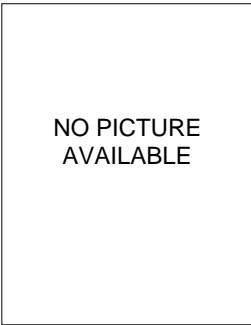

EVENT #05997 THIS IS A BWC EVENT. IN SUMMARY: ALL VICTIM'S ARE UNIFORMED CHICAGO POLICE OFFICER'S RESPONDING TO A MAN WITH A KNIFE CALL. OFFENDER PLACED IN CUSTODY FOR AGGRAVATED ASSAULT OF A POLICE OFFICER AFTER RECEIVING MULTIPLE COMMANDS FROM VICTIMS' IN ENGLISH AND CANTONESE TO DROP A LARGE MEAT CLEAVER. OFFENDER WAS STRUCK BY MULTIPLE TASER DEPLOYMENTS BY VICTIMS' WITH LITTLE EFFECT. OFFENDER EMERGED FROM BEDROOM WITH CLEAVER IN HAND CLOSING THE DISTANCE BETWEEN OFFENDER AND VICTIMS, THEREFORE PLACING ALL VICTIMS IN IMMEDIATE APPREHENSION OF RECEIVING A BATTERY. R/O PEREZ #14864, BEING IN FEAR FOR HIS AND OTHER OFFICER'S LIVES DISCHARGED HIS SERVICE WEAPON STRIKING OFFENDER IN THE UPPER THIGH CAUSING OFFENDER TO DROP CLEAVER AND FALL TO THE FLOOR. NO GIPP.
