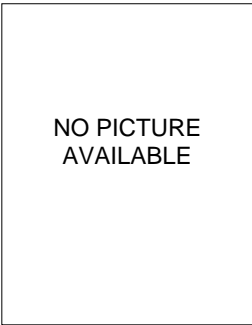

EVENT #02432 IN SUMMARY, ABOVE IS BEING ARRESTED ON SIGNED COMPLAINTS. OFFENDER, ROBERT JOHNSON, WAS CAUSING A DISTURBANCE IN THE FRONT LOBBY AND THE OFFENDER WAS ESCORTED OUTSIDE. AS R/O'S APPROACHED, THEY WITNESSED THE OFFENDER KICKING AT P.O. ALEXANDER #8860. OFFENDER ALSO GRABBED P.O DARBY #14283 BY THE ARM AND PUSHED HIM. OFFENDER FAILED TO COMPLY TO VERBAL COMMANDS AT WHICH TIME, P.O BUCKHALTER #10109, GAVE A VERBAL WARNING THAT SHE WOULD DISCHARGE HER TASER IF HE FAILED TO COMPLY WITH OFFICERS COMMANDS. OFFENDER DID NOT COMPLY, AT WHICH TIME P.O. BUCKHALTER DISCHARGED HER TASER, STRIKING THE OFFENDER CAUSING HIM TO FALL TO THE GROUND CAUSING A GASH TO HIS HEAD. OFFENDER WAS TRANSPORTED TO ST.
