NARRATIVES	<p>EVENT#02432 BWC EVENT. IN SUMMARY THERE WAS A DISTURBANCE OUTSIDE THE 002ND DISTRICT STATION. ROBERT JOHNSON(OFFENDER) WAS BEING REMOVED FROM THE STATION FOR CAUSING A DISTURBANCE WITH THE DESK PERSONNEL. P.O. ALEXANDER (VICTIM AND COMPLAINANT) AND P.O. DARBY (VICTIM AND COMPLAINANT) WERE OUTSIDE TO MAKE SURE THE OFFENDER LEFT THE PREMISES. ROBERT JOHNSON(OFFENDER) BEGAN TO TRY AND FIGHT THE DESK STAFF. ROBERT JOHNSON(OFFENDER) GRABBED P.O. DARBY (VICTIM AND COMPLAINANT) AND THEN BROKE FREE FROM THE P.O DARBY. ROBERT JOHNSON(OFFENDER) THEN BEGAN TO TRY AND KICK P.O. ALEXANDER (VICTIM AND COMPLAINANT). AFTER SEVERAL ATTEMPTS TO DEFUSE THE SITUATUON, P.O LISA BUCKHALTER (RO) THEN DEPLOYED HER TASER TO GET THE OFFENDER UNDER CONTROL AND TO PREVENT FURTHER ATTACK. P.O'S ALEXANDER (VICTIM AND COMPLAINANT) AND DARBY (VICTIM AND COMPLAINANT) THEN PERFORMED EMERGENCY CUFFING TO THE OFFENDER. BELINDA BELCHER (RO) CALLED FOR AN AMBULANCE TO RENDER AID TO THE OFFENDER. AMBULANCE #36 ARRIVED AND TRANSPORTED THE OFFENDER TO ST. BERNARD'S HOSPITAL FOR TREATMENT OF A HEAD WOUND SUFFERED FROM THE FALL FROM BEING TASERED. BEAT 225R FOLLOWED THE AMBULANCE WITH THE OFFENDER.
