UPON A/O'S ARRIVAL TO THE SCENE, A/O'S OBSERVED ABOVE OFFENDER AND 2 OTHERS IN AN ON GOING PHYSICAL ALTERCATION WITH THE ABOVE VICTIMS IN THAT ABOVE OFFENDER WAS WRESTLING AND STRUGGLING WITH [REDACTED] (VICTIM). A/O'S SEPERATED BOTH PARTIES TO CONTAIN THE DISTURBANCE.
