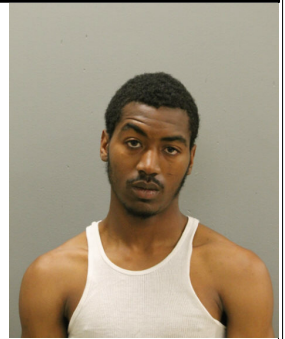

A/O BROWN # 15887 WORKING BEAT 332 RELATED THAT THE SUBJECT NOW KNOWN AS MICHAEL P LEE WAS RUNNING NORTHBOUND ON THE 6600 BLOCK OF SOUTH GREENWOOD SWEATING AND SHORT OF BREATH AND DIRECTLY MATCHING THE ABOVE DESCRIPTION. A/O BROWN THEN ORDERED ARRESTEE TO LAY ON THE GROUND AND WAS THEN TEMPORARILY DETAINED. A/O ASTORGA # 14757 THEN POSITVELY IDENTIFIED THE ARRESTEE AT 1450 HOURS.
