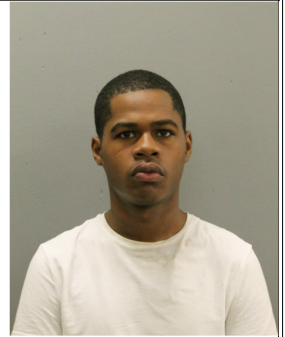

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT # 10644 THIS WAS A BWC RECORDED EVENT BY BEAT 602S2. ABOVE ARRESTEE (TYRIK WILSON) WAS OBSERVED BY FIRST ARRIVING OFFICERS AS THE REAR PASSENGER OF THE ABOVE LISTED VEHICLE (2011 KIA SORENTO BEARING ILLINOIS LICENSE PLATE [REDACTED] REPORTED STOLEN UNDER RD # JB276170. VEHICLE THEN CRASHED (REPORTED UNDER RD # JB278224) AND ARRESTEE FLED NORTHBOUND ON THE 6600 BLOCK OF SOUTH INGLESIDE. A/O'S WERE DIRECTED BY MULTIPLE UNKNOWN CITIZENS STANDING ON THE PUBLIC WAY TOWARDS THE ARRESTEES LOCATION OF [REDACTED] S INGLESIDE IN THE REAR. A/O'S THEN OBSERVED A SUBJECT DIRECTLY MATCHING A DESCRIPTION, WHITE SHIRT AND BLUE PANTS, GIVEN OVER OEMC ZONE 8 BY BEAT 6726B. A/O'S THEN OBSERVED THE SUBJECT NOW KNOWN AS TYRIK WILSON ATTEMPTING TO CONCEAL HIMSELF ON THE THIRD FLOOR REAR PORCH BY ATTEMPTING TO LAY IN AN AREA BEHIND WOOD PANELING OF SAID REAR PORCH. UPON A/O'S APPROACH ARRESTEE WAS BREATHING HEAVILY, SWEATING, AND HAVING AN ACCELERATED HEART RATE. ARRESTEE WAS THEN DETAINED AND WALKED TO THE FRONT OF THE LOCATION WHERE HE WAS POSITIVELY IDENTIFIED BY A/O VINCENT # 15162 AT 1454 HOURS. ARRESTEE WAS THEN PLACED INTO CUSTODY AND TRANSPORTED TO AREA SOUTH FOR FURTHER PROCESSING BY BEAT 602S2 AND 6726D. BASED ON ARRESTEE'S POST MIRANDA ADMITTANCE ARRESTEE IS BEING CHARGE WITH AGG UUW IN THAT HE ADMITTED TO THROWING A FIREARM THAT WAS RECOVERED FROM 6622 S INGLESIDE ON THE ROOF OF THE RESIDENCE. BASED ON COOPERATIVE OFFENDER STATEMENTS, THE ABOVE OFFENDER HAS BEEN IDENTIFIED AS BEING INVOLVED IN THE SHOOTING OF [REDACTED] AT [REDACTED] [REDACTED] RECORDED UNDER RD # JB278224. ARRESTEE HAD NO USC ON HIS PERSON AND NO PERSONAL PROPERTY. NAME CHECK CLEAR. NO WANTS/WARRANTS. NO INVESTIGATIVE ALERTS. NO PAROLE/PROBATION.
