# SUMMARY REPORT OF INVESTIGATION

#### I. EXECUTIVE SUMMARY

As seen on the Accused Officer's dashcam, Complainant Involved Civilian 1 ran a stationary stop sign. After observing Involved Civilian 1 run the stop sign, the Accused Officer initiated a traffic stop, and cited her for the traffic violation. Afterwards, Involved Civilian 1 initiated this complaint, asserting that the officer improperly issued her the citation.

### V. INVESTIGATION<sup>1</sup>

#### a. Interviews

Complainant Involved Civilian 1 provided a statement to COPA on July 26, 2018, and a summary follows. She stated that, on July 7, 2018, at approximately 9:45am, she was west bound on XXX<sup>th</sup> Street in Chicago, when she was stopped by CPD. She stated that two uniformed officers approached her vehicle with extreme caution.<sup>2</sup> Involved Civilian 1 also claims that the female officer [later identified as Officer A] told her she was stopped because there was "a lot of movement in her vehicle." [<sup>4</sup>].

Involved Civilian 1 states that the female officer took her driver's license and insurance information back to the police vehicle. She claims that the officers took an excessive amount of time before returning to give her a traffic ticket. Involved Civilian 1 denied running the stop sign and began to question the female officer on why she was stopped. After the officer gave Involved Civilian 1 the citation, both officers returned to their vehicle and left.

## b. Digital Evidence

The officers' **Dash Cam video** shows a Silver Chrysler, fail to stop at a at an intersection with a 3-way stop.<sup>5</sup> Notably, multiple preceding vehicles had all come to a complete stop at the intersection. Officers promptly curbed the vehicle and Officer A issued the driver, Involved Civilian 1 a citation for running the stop sign.

The **BWC** and **Dash Cam** footage both show the officers approaching Involved Civilian 1's vehicle, obtaining her license and registration, returning to their car to run registration, and finally giving the Involved Civilian 1 the traffic citation. BWC footage shows that the officers spent approximately seven minutes in their car as they ran Involved Civilian 1's information.

Additionally, the **BWC footage** covers the entirety of the officers' interactions with Involved Civilian 1. This includes Officer A advising Involved Civilian 1 that she was stopped for running the stop sign and advising her that the incident was being recorded. In the video, Involved Civilian 1 is argumentative, denies running the stop sign, and initially refuses to sign the ticket before relenting.

#### VI. ANALYSIS

In their conversation, Involved Civilian 1 inquires as to the need for the "cautious" approach. Officer A informed here that they saw movement inside the car as it was stopping. Involved Civilian 1 pointed to a young boy in the front seat, indicating that his movements were what the officers saw. Neither the video nor the conversations between the officers and Involved Civilian 1 indicate that any weapons were improperly displayed.

Dash Cam footage clearly shows Involved Civilian 1 failing to stop at a stop sign after at least 3 prior vehicles had made complete stops. In the BWC video, the officers were courteous and they verified the license and registration and prepared the citation without delay. The officers were not argumentative and waited patiently as Involved Civilian 1 challenged them as to the reason for the stop. Accordingly, the allegation against P.O. A is Exonerated.

# VII. CONCLUSION

Based on the analysis set forth above, COPA makes the following findings:
