NARRATIVE

EVENT #18874 IN SUMMARY, THIS IS AN ON VIEW ARREST BY BEAT 963D IN THAT WHILE ON PATROL IN A HIGH GANG AND VIOLENCE AREA R/O'S OBSERVED THE ABOVE LISTED PERSON IN A BLUE SWEATSHIRT AND A CUBS JERSEY QUICKLY WALK INTO THE ALLEY BY THE ADDRESS OF 4642 S. TALMAN ALONG WITH ANOTHER UNKNOWN MALE HISPANIC IN A GRAY SWEATSHIRT. R/O'S TURNED INTO THE ALLEY AND OBSERVED THE INDIVIDUAL IN THE BLUE SWEATSHIRT AND CUBS JERSEY WALKING QUICKLY AND PULLED ALONGSIDE OF HIM. R/O'S OBSERVED THE INDIVIDUAL, MATTHEW AGUILAR(OFFENDER), WITH BOTH HANDS TUCKED INSIDE THE FRONT OF HIS SWEATSHIRT POCKET. OFFENDER THEN CHANGED DIRECTION AND AS HE PASSED R/O'S VEHICLE, R/O'S ORDERED THE OFFENDER TO TAKE HIS HANDS OUT OF HIS POCKET AND OBSERVED A LARGE BULGE IN THE FRONT OF HIS SWEATSHIRT. OFFENDER IMMEDIATELY TOOK OFF RUNNING AND BELIEVING OFFENDER WAS IN POSSESSION OF A WEAPON, P.O ZULEVIC GAVE CHASE ON FOOT TRAVELING SOUTH AND THEN EAST IN THE ALLEY. OFFENDER THEN TURNED SOUTH ONTO TALMAN AT WHICH TIME P.O. ZULEVIC HEARD A LOUD KLING ON CEMENT BELIEVING IT TO BE A METAL OBJECT HITTING THE STREET. P.O. ZULEVIC EXITED THE ALLEY AND OBSERVED OFFENDER IN A PARTIALLY BENT POSITION WITH ARMS EXTENDED TOWARDS THE CURB NEAR A BLUE HONDA PARKED ON THE WEST SIDE OF THE STREET. OFFENDER THEN CONTINUED TO RUN SOUTH TOWARDS 47TH STREET ON TALMAN WHERE THE UNKNOWN SUBJECT IN THE GRAY SWEATSHIRT WAS ALSO RUNNING AHEAD OF THE OFFENDER. P.O. ZULEVIC THEN SLOWED DOWN TO RECOVER WHAT R/O BELIEVED TO BE A WEAPON. HOWEVER, SEEING P.O. DURON CONTINUE TO FOLLOW THE OFFENDER AND UNKNOWN SUBJECT IN THE POLICE VEHICLE AND UNKNOWN IF THE OFFENDER OR IF THE UNKNOWN SUBJECT HAD ANY ADDITIONAL WEAPONS P.O. ZULEVIC CONTINUED TO FOLLOW THE UNKNOWN SUBJECT, THE OFFENDER AND P.O. DURON ON FOOT WEST ON 47TH ST. P.O. DURON FOLLOWED THE OFFENDER IN THE POLICE VEHICLE WITH HEADLIGHTS ON WEST ON TO 47TH STREET WHEN OFFENDER SHARPLY TURNED NORTH ON WASHTENAW AT WHICH TIME P.O. DURON ALSO TURNED NORTHBOUND ON WASHTENAW. AS P.O. DURON TURNED HE HEARD A LOUD THUMP AS HIS VEHICLE DROVE OVER A LARGE CONSTRUCTION METAL PLATE ON THE PAVEMENT BRIEFLY DRAWING HIS ATTENTION AWAY FROM THE OFFENDER. THE OFFENDER THEN RAN FROM THE EAST TO THE WEST SIDE OF THE STREET ON WASHTENAW WHEN P.O. DURON HEARD THE SOUND OF IMPACT AGAINST THE SIDE OF THE POLICE VEHICLE. P.O. DURON IMMEDIATELY STOPPED AND EXITED HIS VEHICLE TO ASSESS THE SITUATION AND OBSERVED THE OFFENDER ON THE GROUND WITH HIS HOOD UP OVER HIS HEAD IN NEED OF MEDICAL ATTENTION. P.O. DURON IMMEDIATELY CALLED FOR AN AMBULANCE FOR THE OFFENDER AND ATTEMPTED TO PLACE OFFENDER IN CUSTODY. P.O. DURON OBSERVED OFFENDER REPEATEDLY ATTEMPTING TO STAND UP AND ORDERED THE OFFENDER TO STAY DOWN AS THE AMBULANCE WAS ENROUTE. OFFICERS ON SCENE TRIED TO RENDER AID WITH MEDICAL GAUZE PRIOR TO AMBULANCE 69'S ARRIVAL. AFTER SEEING OFFENDER WAS SECURE ON WASHTENAW, P.O. ZULEVIC THEN RAN BACK TO TALMAN TO THE SAME BLUE HONDA WHERE SHE OBSERVED OFFENDER HAD THROWN A GUN AND OBSERVED OFFENDER RUNNING FROM AND RECOVERED 1 BLACK 9MM / BERETTA / SERIAL #038227MZ / 4.5IN BARREL / MODEL 8000 D, LOADED WITH 1 BLACK MAGAZINE CONTAINING NUMEROUS LIVE ROUNDS. CFD AMBULANCE 69 TRANSPORTED THE OFFENDER TO MT. SINAI ALONG WITH 923R. DR. SLOBODKIN LISTED OFFENDER IN CRITICAL BUT STABLE CONDITION. ET, DELTORO #8853 BT 5812, ON SCENE AT HOSPITAL AT 0221HRS AND WAS ABLE TO IDENTIFY OFFENDER BY FINGERPRINTS. ET ALSO PROCESSED POLICE VEHICLE AT 0430HRS. MAUI, FLIGELMAN #7607 BT 5787 ON SCENE AT 0248HRS. STREET DEPUTY ON SCENE, CAR 4C D/C O'DONNELL #13. SGT DARLING #1321, BT 965 ON SCENE. CAPTAIN JEROME 900X ON SCENE. TRAFFIC CRASH REPORTED UNDER JB469496.
