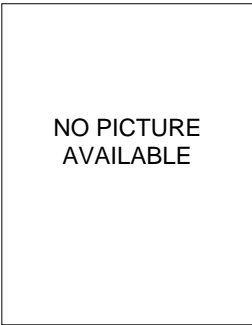

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT # 13465. BWC related arrest, ISR completed (# 201804484). In summary, On 31 October 2018 at approximately 1911 hours A/O's working in plainclothes were assigned to 664A. While on patrol in an unmarked Chicago Police Department squad car in the area of 7900 S. Drexel, A/O's observed a group of subjects, some of which were known members that frequent the area gathered at the approximate address of 7901 S. Drexel. A/O's being aware that this location has been designated as a gang and narcotics Hotspot (#1) stopped, exited the vehicle and began to approach the group on foot. At that time A/O's observed a male, Black subject, wearing dark clothing abruptly start to walk away from the group while clutching his waist area. A/O Martinez #12428 asked the subject to step over, at which point he began to flee southbound on foot. A/O's pursued the offender on foot as he continued to hold his waist area. The offender proceeded through a gang way and into the rear of an apartment building and up some stairs. The offender then ran into a third floor apartment and slammed the door shut with A/O Martinez in pursuit. A/O Martinez made a forced entry into that apartment at which time the offender was observed inside the apartment with a gun in his hand. A/O Martinez gave verbal commands for the offender to drop his weapon, which he refused and attempted to flee into the front stairwell. The offender proceeded onto and down the stairs, at times turning to have his weapon pointed in A/O Martinez's direction. A/O then discharged his weapon in the direction of the offender striking him. A/O Martinez requested medical treatment for the offender as Beat 664 arrived. Offender placed in custody and transported U of C hospital by Amb 55 for treatment. Offender is a convicted felon under case # 15cr1627501, a documented gang member, and is currently on parole. A/O's notified IDOC @ 0425 (01nov) and spoke to [REDACTED], who issued a warrant for parole violation under tracer # 126414019 No other wants, warrants, or investigative alerts. No court info at this time.
