A/OS OBSERVED [REDACTED] WITH A REVOLVER AND ATTEMPTED TO PLACE HIM IN CUSTODY AND SAFELY RECOVER SAID FIREARM. ABOVE ARRESTEE DISOBEYED A/OS VERBAL DIRECTION AND RAN PAST AREA WHERE OFFICERS WERE STANDING IN ATTEMPT TO AID [REDACTED] AND STOP A/OS FROM HANDCUFFING HIM. A/O WARREN ATTEMPTED TO ESCORT ARRESTEE AWAY AT WHICH POINT HE PULLED AWAY FROM HIS GRASP AND A/O WARREN PERFORMED AN EMERGENCY TAKEDOWN.
