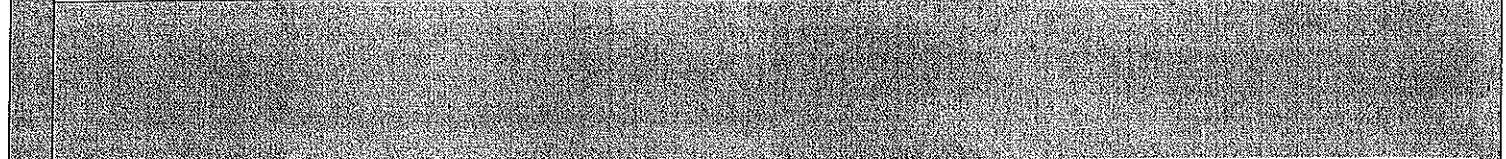

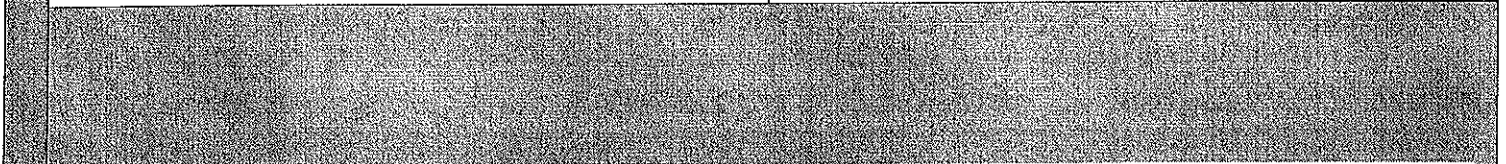

NARRATIVE

EVENT #01714, IN SUMMARY, R/O'S RESPONDED TO A SUPERVISOR ASSIST TO DISPERSE AN ON-GOING LARGE PARTY IN THE 5900 BLOCK OF EMERALD IN THE WEST ALLEY. THERE HAD BEEN SEVERAL PREVIOUS CALLS TO THIS LOCATION. THIS WAS R/O'S THIRD RESPONSE TO BREAK UP THE ILLEGAL PARTY WHICH INCLUDED LOUD MUSIC, DRINKING ON THE PUBLIC WAY, ILLEGALLY PARKED VEHICLES AND PEDESTRIANS BLOCKING THE ALLEY. AS R/O'S ATTEMPTED TO ASSESS THE SITUATION TO DISPERSE THE CROWD ON THE PUBLIC WAY, PO FILETTI #15785, PO VINAKOS #19221 AND PO FERRANTELLA #11403 WERE IN THE ALLEY AT WHICH TIME THEY OBSERVED A M/1 SUBJECT INSIDE THE GATE, NOW KNOWN AS [REDACTED] (OFFENDER) WITH THE HANDLE OF A GUN PROTRUDING FROM HIS RIGHT PANTS POCKET. R/O'S ALERTED OTHER OFFICERS ON SCENE, AND ENTERED THE REAR YARD THROUGH THE GATE TO PLACE THE OFFENDER INTO CUSTODY. AS R/O'S APPROACHED [REDACTED] (OFFENDER), THE OFFENDER THEN PLACED HIS BACK AGAINST A CAR AND BEGAN SLIDING DOWN TO THE GROUND. GEELA WILLIAMS(OFFENDER), PLACED HER BODY IN FRONT OF [REDACTED] (OFFENDER), BLOCKING R/O'S ATTEMPT TO PLACE HIM INTO CUSTODY. AT THIS TIME, PO FILETTI #15785 (VICTIM AND COMPLAINANT) THEN OBSERVED THE [REDACTED] (OFFENDER) PLACE HIS HAND ON THE HANDLE OF THE GUN PROTRUDING FROM HIS RIGHT JEANS POCKET. PO FILETTI #15785 GAVE OFFENDER VERBAL DIRECTION TO PUT HIS HANDS UP AND GET DOWN ON THE GROUND. PO WARREN #18398 (VICTIM AND COMPLAINANT), RECOGNIZING THE SERIOUSNESS OF THE SITUATION, PUSHED GEELA WILLIAMS(OFFENDER) TO THE SIDE WITH HIS LEFT HAND AS SHE WAS STILL OBSTRUCTING R/O'S ATTEMPTS TO PLACE [REDACTED] (OFFENDER) INTO CUSTODY. AS [REDACTED] (OFFENDER) CONTINUED TO MOVE DOWN TO THE GROUND, PO FILETTI #15785 OBSERVED THE OFFENDER PULL THE WEAPON FROM HIS POCKET AND THROW IT ONTO THE GROUND. AS R/O'S THEN ATTEMPTED TO FINALLY PLACE [REDACTED] (OFFENDER) INTO CUSTODY, [REDACTED] (OFFENDER) RAN INTO THE GROUP OF OFFICERS FURTHER DEFEATING THE ARREST. PO WARREN #18398 GAVE VERBAL COMMANDS TO [REDACTED] (OFFENDER) AND ATTEMPTED TO ESCORT [REDACTED] (OFFENDER) AWAY, AT WHICH POINT [REDACTED] (OFFENDER) PULLED AWAY FROM PO WARREN'S GRASP AND REFUSED VERBAL COMMANDS. PO WARREN #18398 THEN PUT HIS ARMS AROUND [REDACTED] (OFFENDER) AND PERFORMED EMERGENCY HANDCUFFING. PO WARREN HIT HIS LEFT KNEE ON THE GROUND, CAUSING PAIN AND REDNESS. WHILE ON THE GROUND, [REDACTED] (OFFENDER) CONTINUED TO RESIST BY PULLING HANDS AWAY AS PO WARREN PLACE INTO CUSTODY. AT THIS POINT, [REDACTED] (OFFENDER) AND [REDACTED] (OFFENDER) WERE SUCCESSFULLY PLACED INTO CUSTODY. DUE TO THE AMOUNT OF SUBJECTS ON SCENE, PO BANDOLA #7610 RECOVERED (1) BLUE STEEL REVOLVER RUGER GP100 357 MAGNUM WITH A 4INCH BARREL WITH 6 LIVE ROUNDS AND BROUGHT TO 007TH DISTRICT STATION FOR INVENTORY (INVENTORY #13968250). BOTH OFFENDERS TRANSPORTED BY BT 773R AT 0320 HRS TO 007TH DISTRICT STATION FOR FURTHER PROCESSING. GEELA WILLIAMS(OFFENDER) COMPLAINED OF PAIN TO THE RIGHT LEG, AND WAS TRANSPORTED BY CFD AMB #1 TO ST BERNARD'S HOSPITAL. AT THE TIME OF THE INCIDENT, R/O'S WERE NOT CERTAIN GEELA WILLIAMS(OFFENDER) WAS CONTINUALLY PHYSICALLY ATTEMPTING TO INTERFERE WITH THE ARREST OF [REDACTED] OR ACTIVELY RESISTING VERBAL COMMANDS, THEREFORE, MEDICAL ATTENTION WAS GIVEN BUT A PHYSICAL ARREST WAS NOT MADE AT THE TIME. AFTER REVIEWING BODY CAM FOOTAGE OF THE ARREST IN THE 007TH DISTRICT, R/O'S OBSERVED THAT GEELA WILLIAMS(OFFENDER) WAS CONTINUALLY BLOCKING R/O'S ATTEMPTS TO PLACE [REDACTED] (OFFENDER) INTO CUSTODY WHILE BRANDISHING A LARGE GLASS BOTTLE AND REFUSING R/O'S ORDERS. GEELA WILLIAMS(OFFENDER) STATED ON BODY CAMERA THAT "ALL I WAS DOING WAS HOLDING HIM" AND "YALL PUSHED ME OFF HIM" "HES MY MAN" INDICATING SHE WAS PURPOSELY ATTEMPTING TO AID THE DEFEAT OF [REDACTED] ARREST. TRR'S COMPLETED. THIS EVENT RECORDED ON BODY WORN CAMERAS.
