AFTER REVIEWING THE INFORMATION AVAILABLE TO ME AT THIS TIME, INCLUDING AVAILABLE VIDEO, I HAVE CONCLUDED THAT THE SUBJECT WAS ARMED WITH A FIREARM AND WAS SUBSEQUENTLY ARRESTED. ON BWC, THE SUBJECT ALLEDGED THAT HIS WRISTS WERE INJURED. OFFICERS USED TWO SETS OF HANDCUFFS TO MAKE THE SUBJECTS HANDS SECURE AND SAFE BUT TO AVOID INJURY, THE SUBJECT MADE NO STATEMENTS TO R/LT, HOWEVER, HE STATED TO SGT, ZATTAIR #828 THAT HIS WRIST WAS PREVIOUSLY INJURED IN A VEHICLE CRASH BUT DECLINED THE OFFER OF MEDICAL ATTENTION. THIS TRR IS TO DOCUMENT THE SUBJECTS ALLEGIONS OF INJURY RECORDED ON BWC.
