(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT #09374 IN SUMMARY, [REDACTED] (TCF EMPLOYEE) RELATED THAT ABOVE SUBJECT CAME TO THE TCF BANK LOCATED AT 2301 N HARLEM AVE AND ATTEMPTED TO OPEN A BANK ACCOUNT WITH FRAUDULENT ILLINOIS I.D CARD WITH A NAME OF [REDACTED] WITH A BIRTHDAY OF [REDACTED] 1973 AND THE ADDRESS OF [REDACTED] CHICAGO, IL, 60660. COMPLAINANT FURTHER RELATED THAT PRIOR TO ABOVE INCIDENT, THEY RECEIVED AN EMAIL WITH ABOVE OFFENDER ATTEMPTING TO OBTAIN A CASH ADVANCE WITH A FRAUDULENT ILL ID CARD AND A CREDIT CARD FROM CAPITALONE ON 29 SEP 2017 AT THE TCF BANK BRANCH LOCATED AT 4729 N CENTRAL AVE. HOWEVER, ABOVE SUBJECT FLED THE SCENE PRIOR TO POLICE ARRIVAL. R/O'S TOOK POSSESSION OF THE FRAUDULENT ID AND R/O'S ATTEMPTED TO PLACE ABOVE SUBJECT INTO CUSTODY AT WHICH TIME ABOVE SUBJECT RAN THROUGH THE LOBBY OF THE BANK TOWARD THE EMERGENCY EXIT DOOR. ABOVE SUBJECT AS HE EXITED THE DOOR THEN LOST BALANCE WHILE RUNNING AT WHICH TIME PO GORZELANY WAS ABLE TO GET A GRIP ON OFFENDER'S SHIRT AND BOTH PO GORZELANY #11422 AND ABOVE SUBJECT FELL TO THE GROUND CAUSING ABOVE SUBJECT TO STRIKE HIS FACE AGAINST THE PAVEMENT. PO GORZELANY #11422 THEN WAS ATTEMPTING TO HANDCUFF ABOVE OFFENDER, HOWEVER, THE OFFENDER REFUSED SEVERAL VERBAL COMMANDS TO STOP RESISTING WHILE FLAILING HIS RIGHT ARM WITH A CLENCHED FIST ATTEMPTING TO DEFEAT AN ARREST. PO MESSINO#18980 THEN ATTEMPTED TO GAIN CONTROL OF SUBJECT'S RIGHT ARM AND IN FEAR OF RECEIVING A BATTERY, PO MESSINO #18980 STRUCK ABOVE OFFENDER SEVERAL TIMES INTO UPPER TORSO AREA WITH HIS KNEE ATTEMPTING TO DEFEAT OFFENDER'S MECHANICAL MOVEMENT AND STRUCK OFFENDER IN THE FACE AFTER HE CONTINUED TO RESIST AN ARREST. R/O'S STRUGGLED ON THE GROUND AND USED NECESSARY FORCE TO EFFECT AN ARREST. SUBJECT THEN WAS PLACED INTO THE BACK OF THE SQUAD CAR AND STATED "YOU ARE LUCKY I AM HANDCUFFED OR I WOULD BEAT YOUR ASS." OFFENDER ALSO STATED "ONCE WE GET TO THE STATION, WE CAN GO ONE ON ONE." WHILE BEING TRANSPORTED TO 25TH DISTRICT. OFFENDER THEN WAS TRANSPORTED TO COMMUNITY FIRST HOSPITAL AND TREATED FOR BRUISES TO HIS FACE AREA. ABOVE HAS ILL DRIVER LICENSE AND NO USC. ABOVE HAS PRIOR THEFT AND RESISTING ARREST/OBSTRUCTING CHARGES/CONVICTIONS. FINANCIL CRIME AREA NOTIFIED AT 1700 HRS, BRYANT #20587, BEAT 5719. EVIDENCE INVENTORIED UNDER, 14016280, 14016288, 14016296. NO RECORD OF FRADULENT ID VIA LEADS INQUIRY.
